Synopsis: A Resolution to amend the Annual Budget and Appropriation Ordinance for Cecil County, Maryland for the fiscal year ending June 30, 2020 in order to provide a total of \$52,920 to the Special Revenue Other Grants Fund-Roads Administration Department to record the incentive awarded from Delmarva Power for the purpose of retrofitting the buildings at the Roads Central Yard with LED lighting.

Supplemental Appropriation – Grant Funds – Roads Department – Central Yard LED Lighting

1 **WHEREAS**, in accordance with Section 505 of the Cecil County Charter, on April 1, 2019, the
2 County Executive submitted a proposed budget to the County Council for Fiscal Year 2020; and
3 **WHEREAS**, in accordance with Section 506 of the Cecil County Charter, the County Council held
4 public hearings on the proposed budget submitted by the County Executive for Fiscal Year 2020; and
5 **WHEREAS**, in accordance with Section 507(b) of the Cecil County Charter, on June 4, 2019, the
6 Budget for Cecil County was adopted for Fiscal Year 2020; and
7 **WHEREAS**, the County Executive is revising the Fiscal Year 2020 Special Revenue Other Grants
8 Fund – Roads Administration revenue estimate for Cecil County to establish the following amount: the
9 addition of \$52,920 in grant revenue and expense to the Special Revenue Other Grants Fund – Roads
10 Administration operating budget to provide for the Delmarva Power incentive award to Cecil County;
11 and
12 **WHEREAS**, such appropriation is necessary to provide \$52,920 in program funding to allow for
13 the retrofit of LED lighting at the Roads Department Buildings at the Central Yard. The total cost of the
14 project is \$60,096, leaving the County to pay \$7,176 of the total project cost.
15 **NOW THEREFORE, BE IT HEREBY RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY,**
16 **MARYLAND**, that the Annual Budget and Appropriation Ordinance for Cecil County, Maryland for Fiscal
17 Year 2020 is hereby amended for the supplemental appropriation, and by amending the Current
18 Budget to appropriate \$52,920 in additional expenditures in the Special Revenue Other Grants Fund –
19 Roads Administration Department to record the incentive awarded from Delmarva Power for the
20 purpose of retrofitting the buildings at the Roads Central Yard with LED lighting
21 **AND BE IT FURTHER RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND**, that
22 this Resolution shall take effect on the date of its passage.
