COUNTY COUNCIL OF CECIL COUNTY LEGISLATIVE SESSION MINUTES LSD 2019-23 December 3, 2019

The County Council of Cecil County met in legislative session at the County Administration Building, 200 Chesapeake Blvd., Elk Room, Elkton, MD. The following members of the Council were present:

CALL TO ORDER

The meeting of the County Council of Cecil County of December 3, 2019 was called to order by Council President Meffley at 7:00 p.m. and opened with the Pledge of Allegiance.

OPENING PRAYER

Councilman Miller introduced Pastor Tim Beardsley from Cherry Hill United Methodist Church, who led the opening prayer.

APPROVAL OF AGENDA

On motion made by Councilman Coutz, seconded by Vice President Gregory, the Council moved to approve the legislative agenda of December 3, 2019. Motion was unanimously approved.

PUBLIC HEARINGS

Council Manager Massey stated for the record:

FILE: 2019-03; APPLICANT: Wood Family Properties, LLC.; REQUEST: Request to rezone 1.9 acres from High Density Residential, (RM) to Business General, (BG); PROPERTY LOCATION: 5233 Pulaski Hwy, Perryville, MD 21903. Election District: 7, Tax Map: 800, Parcel: 682; PROPERTY OWNER: Wood Family Properties, LLC, Ron Wood- Managing Member; PRESENTLY ZONED High Density Residential, (RM)

Notice of the public hearing was published on November 20, 2019 and November 27, 2019.

Witnesses presenting testimony were sworn in by the Council Manager.

Jay Emrey, representing the applicant, presented the request for rezoning, based on a mistake in the Comprehensive Rezoning of May 1, 2011. He introduced Ron Wood, as a witness.

Mr. Emrey provided copies of Exhibit A, a black and white aerial photo of the property with identification of the various existing properties and property lines. He also provided copies of Exhibit B, the real property data search for the parcel from the State Department of Assessments and Taxation.

Eric Sennstrom, Director of Land Use and Development Services, stated that the Planning and Zoning staff and Planning Commission recommended approval, based on a demonstrated mistake in the Comprehensive Rezoning. Bryan Lightner, Zoning Administrator, presented the staff report of findings of facts, which recommended approval based on a demonstrated mistake in the Comprehensive Rezoning.
