Supplemental Appropriation – Fund Balance – Roads and Bridges Capital Budget-**Belvidere Road Culvert Replacement**

WHEREAS, in accordance with Section 505 of the Cecil County Charter, on April 1, 2019, the 1 2 County Executive submitted a proposed budget to the County Council for Fiscal Year 2020; and 3 WHEREAS, in accordance with Section 506 of the Cecil County Charter, the County Council held 4 public hearings on the proposed budget submitted by the County Executive for Fiscal Year 2020; and 5 WHEREAS, in accordance with Section 507(b) of the Cecil County Charter, on June 4, 2019, the 6 Budget for Cecil County was approved for Fiscal Year 2020; and WHEREAS, the County Executive is revising the Fiscal Year 2020 revenue estimate within the 7 8 Roads and Bridges Capital Projects Fund by \$150,000 to allow the following appropriation within the 9 Capital projects Fund: the addition of \$150,000 in expenditures to complete the culvert replacement 10 on Belvidere Road. Using a compressed schedule, the bids for this project came in higher than the 11 engineer's estimates; and WHEREAS, such appropriation is necessary to provide \$150,000 of the FY2019 assigned fund 12 balance of the General Fund for expenditures on Belvidere Road to be transferred to the Capital Projects 13 14 Fund; and 15 WHEREAS, Section 506 of the Charter of Cecil County requires that no final budget action may 16

be taken by the County Council until after public hearing or hearings have been held in open public session.

NOW THEREFORE, BE IT HEREBY ENACTED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND, that the Annual Budget and Appropriation Ordinance for Cecil County, Maryland for Fiscal Year 2020 is hereby amended for the supplemental appropriation, and by amending the Budget to appropriate expenditure authority within the Roads and Bridges Capital Projects Budget in the amount of \$150,000 from the General Fund – Assignment of Fund Balance.

AND BE IT FURTHER ENACTED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND, that this legislation shall take effect sixty calendar days from the date that it becomes law.
