Old Business - Review and update list of draft of APM Goals dated 9/17/08. Also reviewed COC Aligned Goals dated 12/10/08 drafted by Diane Lane. She looked at the various goals of the subcommittees to see where the areas of commonality are and them into 5 areas. At the end of each of goals there are initials which represent the subcommittees. 75% of the goals are listed in here and the other 25% were too directed. List is only for information purposes. Diane Lane will provide the other 25% later. Some are in conflict. Two biggest areas are in infrastructure and preservation.

Chairman Thorne: We will focus on our list and discuss changes or additions. We'll start in the middle of the first page at "Protect, preserve and promote our sustainable agriculture, agribusiness & forest products industries.

On #7 change to - Protect, preserve and sustain at least 80% of remaining agricultural and forested land outside the designated growth areas. This creates adopted goal #9.

Unanimously adopted. It will be added to our adopted goals list.

- #18. Last sentence becomes a bullet point under #4 of adopted goals: Delegate responsibility for maintaining open space and hold those responsible for failure to do so.

#28. "Identify and create additional funding sources for preservation." Place under #3 of adopted goals another bullet. Also change under #3 to "Maximize participation in land conservation and preservation programs, including but not limited to MALPH, Rural Legacy, Program Open Space, Forest Legacy and Federal programs."

#33. Change #2 of adopted goals to "Discourage the rezoning of rural property for anything other than value added agricultural related enterprises. Identify and protect our agricultural and forested lands and encourage sustainable agribusiness and other resource based industries by including value added agricultural enterprise in the zoning code."

Now reviewing the top of the first page of the Draft Goals (9/17/08) which is entitled "Limit projected population increase using land use planning, zoning, regulation 7 taxing tools."

#2. Change on #3 to say Restrict growth in no growth areas by:
