COUNTY COUNCIL OF CECIL COUNTY WORK SESSION MINUTES January 7, 2020

Approval of Minutes

On a motion made by Vice President Gregory, seconded by Councilman Coutz, the Council moved to approve the minutes of the Council work session of December 17, 2019, as presented. Motion was approved unanimously.

2020 Council Calendar

Council Manager Massey requested that the Council consider scheduling a legislative session day on December 8, 2020, the second Tuesday in December because there will be no legislative session on December 1, due to the new Council term beginning on Monday, December 7. He explained that since there are no legislative sessions during November, this change will allow pressing legislation to be introduced on December 8 and approved on December 15.

Councilman Coutz made a motion to approve the designation of Tuesday, December 8, 2020, as a legislative session day. The motion was seconded by Vice President Gregory and approved by a vote of 4 to 0. Councilman Patchell was absent.

Cecil County Census Committee

Council Manager Massey provided an update on the Census Committee. The State approved a grant of \$20,000 to be used to encourage Cecil County residents to participate in the 2020 Census. The next meeting of the Census Committee is scheduled on Monday, January 27, 2020.

She suggested that the Council should send a letter in support of the Clean Chesapeake Coalition comments regarding the agreement between Exelon and the State over the relicensing of the Conowingo Dam Hydroelectric Plant. The Council agreed by consensus to send a letter of support.

Council President Meffley wished everyone a Happy New Year. He participated in the New Year's Day 5K run/walk in Chesapeake City. He also stated that the Elkton's Planning and Zoning Board has approved the Southfields proposal with conditions.
