WHEREAS, Pursuant to Article I, Section 270-5 of the Code of Cecil County, Maryland, the County Executive, in accordance with the Charter, shall annually appoint a County Plumbing Board, which shall consist of three members made up of a representative of the Master Plumbers Association of the County, the Health Officer, an architect, engineer, or building and/or any combination thereof; and

WHEREAS, Pursuant to Article I, Section 270-5 of the Code of Cecil County, the County Plumbing Board shall meet at the request of the Chairman or when it is deemed necessary to resolve disputes concerning plumbing installation; and

WHEREAS, The County Plumbing Board shall hear and decide all questions in dispute between property owners, or their agents, and the Plumbing Inspector; and

WHEREAS, The County Plumbing Board shall act as an advisor to the County with respect to the administration and enforcement of the provisions of the Code of Cecil County, Chapter 270 Plumbing; and

WHEREAS, Pursuant to Section 412(b) of the Charter of Cecil County, the Executive shall appoint all members of boards and commissions and that such membership shall be subject to confirmation by the Council; and

WHEREAS, The County Executive has recommended Melvin Reburn for reappointment and Edward Arellano for appointment, to fill the vacancy of Fred von Staden, to the Cecil County Plumbing Board, term to expire on August 31, 2020.

NOW, THEREFORE, BE IT HEREBY RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND, confirms the recommendation by the County Executive of Melvin Reburn for reappointment and Edward Arellano for appointment, to fill the vacancy of Fred von Staden, to the Cecil County Plumbing Board, term to expire on August 31, 2020.

AND BE IT FURTHER RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND, that all provisions of this Resolution shall take effect on the date that the Resolution is adopted by the Council.
