Supplemental Appropriation – Fund Balance – Courthouse Capital Budget-Courtroom #3 Renovation Project

WHEREAS, in accordance with Section 505 of the Cecil County Charter, on April 1, 2019, the

County Executive submitted a proposed budget to the County Council for Fiscal Year 2020; and

WHEREAS, in accordance with Section 506 of the Cecil County Charter, the County Council held

public hearings on the proposed budget submitted by the County Executive for Fiscal Year 2020; and

WHEREAS, in accordance with Section 507(b) of the Cecil County Charter, on June 4, 2019, the

Budget for Cecil County was approved for Fiscal Year 2020; and

WHEREAS, the County Executive is revising the Fiscal Year 2020 revenue estimate within the

General Capital Projects Fund by \$250,000 to allow the following appropriation within the Capital Projects

Fund: the addition of \$250,000 in expenditures to provide sufficient project budget to renovate the

Circuit Court- Court Room #3. During engineering and design of the renovations, it was determined additional budget would be necessary to complete the project because the cost of design and engineering to the detail necessary was not part of the project budget and there would be no project contingency; and

WHEREAS, such appropriation is necessary to provide \$250,000 of the FY2019 assigned fund balance of the General Fund for expenditures to renovate Courtroom #3 to be transferred to the Capital

balance of the General Fund for expenditures to renovate Courtroom #3 to be transferred to the Capital Projects Fund; and

WHEREAS, Section 506 of the Charter of Cecil County requires that no final budget action may be taken by the County Council until after public hearing or hearings have been held in open public session.

NOW THEREFORE, BE IT HEREBY ENACTED BY THE COUNTY COUNCIL OF CECIL COUNTY,

MARYLAND, that the Annual Budget and Appropriation Ordinance for Cecil County, Maryland for Fiscal

Year 2020 is hereby amended for the supplemental appropriation, and by amending the Budget to

appropriate expenditure authority within the General Capital Projects Budget in the amount of \$250,000

from the General Fund – Assignment of Fund Balance to the Courtroom #3 Renovation Project.

AND BE IT FURTHER ENACTED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND, that this legislation shall take effect sixty calendar days from the date that it becomes law.
