# COUNTY COUNCIL OF CECIL COUNTY LEGISLATIVE SESSION MINUTES LSD 2020-04 February 18, 2020

The County Council of Cecil County met in legislative session at the County Administration Building, 200 Chesapeake Blvd., Elk Room, Elkton, MD. The following members of the Council were present:

## **CALL TO ORDER**

The meeting of the County Council of Cecil County of February 18, 2020 was called to order by Council President Meffley at 7:00 p.m.

## **OPENING PRAYER**

Councilman Miller introduced Pastor Lori Brown at Moore's Chapel United Methodist Church, who led the opening prayer.

## **APPROVAL OF AGENDA**

On motion made by Vice President Gregory, seconded by Councilman Coutz, the Council moved to approve the legislative agenda of February 18, 2020. Motion was unanimously approved.

## PRESENTATION OF PROCLAMATION

The Council presented a proclamation to the 2020 Providence Christian Academy Mock Trial Team to recognize their achievements. Certificates were presented to Jackson Cole, Brooke Buckalew, Elle Adkins, Donovan Moore, Felix Cebula, Brittney Willard and Drew Gregory.

## **PUBLIC HEARING**

Council Manager Massey stated for the record:

Rezoning Case 2019-05; APPLICANT: 109-111 Providence Road LLC; REQUEST: Request to rezone 7.29 acres from Rural Residential (RR) to Northern Agricultural Residential (NAR); PROPERTY LOCATION: 109-111 Providence Road, Elkton, MD 21921, Election District: 4, Tax Map: 13, Parcel: 349; PROPERTY OWNER: 109-111 Providence Road LLC; PRESENTLY ZONED: Rural Residential (RR).

Notice of the public hearing was published on February 5, 2020 and February 12, 2020.

Witnesses presenting testimony were sworn in by the Council Manager.

David Fennimore, representing the applicant, presented the request for rezoning, based on a mistake in the 2011 Comprehensive Rezoning. He explained that this property was formerly owned by Spectron, which operated a hazardous waste recycling facility, which had been a Superfund site. He stated that the proposed use would be for solar energy generation.

Eric Sennstrom, Director of Land Use and Development Services, stated that the Planning and Zoning staff and Planning Commission recommended approval, based on a demonstrated mistake in the Comprehensive Rezoning. Bryan Lightner, Zoning Administrator, presented the staff report of findings of facts, which recommended approval based on a demonstrated mistake in the Comprehensive Rezoning.

Council questions and comments ensued. Councilman Coutz clarified that neighboring wells are being monitored.

Council President Meffley opened the public hearing for public comments.

Paul Grube, 46 Morningside Lane, Elkton, commented in opposition to the rezoning case; and stated that his well has never been monitored.

Mr. Fennimore provided concluding remarks and offered to test and monitor Mr. Grube's well.

Council President Meffley concluded the public hearing and announced that the rezoning case will be considered at the next legislative session on March 3, 2020.

### **APPROVAL OF MINUTES**

On motion made by Vice President Gregory, seconded by Councilman Coutz, the Council moved to approve the minutes of the legislative session of February 4, 2020. Motion was approved unanimously.

He went to West Nottingham Academy to discuss the program at Rising Sun High School that takes food waste to a biodigester for the Kilby Farm, which saves money.

Councilman Coutz thanked the audience for attending. He congratulated Providence Christian Academ Mock Trial Team for their achievement and its positive impact on the community.

Vice President Gregory congratulate Tom Berry, coach of the Providence Christian Academy Mock Trial Team for his leadership and dedication to the students. She stated that she testified in opposition to the
