10	June 30, 2021	I, is hereby levied and imposed on all assessments, income, persons or property	
11	subject to ordinary taxation in Cecil County;		
12	2.	That the rate of County taxation for such taxable year for real property is hereby	
13	fixed at One a	and Four Hundred Fourteen Thousandths Cents (\$1.0414) on each \$100 of assessed	
14	valuation of such property;		
15	3.	That the rate of County taxation for such taxable year for personal property, as	
16	well as opera	ting real property (as described in Section 8-109© of the Tax Property Article,	
17	Annotated Co	ode of Maryland) is hereby fixed at 2.6035, which is 2.5000 times the rate as set	
18	forth above f	or real property; and	
19	4.	That the Winding Brook Special Taxing District property tax for the taxable year,	
20	beginning Jul	y 1, 2020 and ending June 30, 2021, is hereby levied and imposed on all parcels in	
21	the Special Ta	exing District at the rate of 277.61 per parcel.	
22	AND E	BE IT FURTHER RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY,	
23	MARYLAND,	that the County Executive and Director of Finance will cause the property tax to be	
24	collected in tl	he manner provided by law.

26	MARYLAND,	that the property and income tax rates shall be effective July 1, 2020 and shall	
27	continue in effect until changed under the laws of the State of Maryland and/or Cecil County.

MARYLAND, that this Resolution shall take effect on July 1, 2020.
