1	WHEREAS, in accordance with Section 505 of the Cecil County Charter, on April 1, 2020, the County
2	Executive submitted a proposed budget to the County Council for Fiscal Year 2021; and
3	WHEREAS, in accordance with Section 506 of the Cecil County Charter, the County Council held
4	public hearings on the proposed budget submitted by the County Executive for Fiscal Year 2021; and
5	WHEREAS, in accordance with Section 507(b) of the Cecil County Charter, on May 19, 2020, the
6	County Council adopted the budget for Fiscal Year 2021; and
7	WHEREAS, the Cecil County Solid Waste Division budget for Fiscal Year 2021 includes funding to
8	purchase a compactor to be used at the Central Landfill, located at 758 East Old Philadelphia Road, Elkton,
9	MD; and
10	WHEREAS, Alban Caterpillar has agreed to offer the County a five year lease financing option to
11	purchase a 2020 Caterpillar Model 826K Landfill Compactor for an annual payment of \$231,946 at a rate of
12	3.35% with an optional buyout at the end of the term in the amount of \$1 (one dollar); and
13	WHEREAS, the proposed lease agreement is in excess of \$20,000 aggregate, and is for multiple fiscal
14	years, for which County Council approval is required in accordance with Section 515(d) of the Cecil County
15	Charter; and
16	WHERAS, the County Executive requests approval of the aforementioned five (5) year lease
17	purchase agreement with Alban Caterpillar.
18	NOW THEREFORE, BE IT HEREBY RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY,
19	MARYLAND, that the County Executive is authorized to enter into a five (5) year lease agreement with
20	Alban Caterpillar with an annual payment amount of \$231,946 to provide financing for a 2020 Caterpillar
21	Model 826K landfill Compactor.
22	AND BE IT FURTHER RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND, that this
23	Resolution shall take effect on the date of its passage.
