**Title of Resolution:** Supplemental Appropriation – Grant Funds – Economic Development – Business Pandemic Relief

**Synopsis:** A Resolution to amend the Annual Budget and Appropriation Ordinance for Cecil County, Maryland for the fiscal year ending June 30, 2020 in order to provide a total of \$5,000 to the Special Revenue Other Grants Fund-Office of Economic Development to record the grant from Baltimore Gas and Electric to provide county-administered business pandemic relief funds to assist small businesses that have been challenged by the economic hardships of the COVID-19 response.

Supplemental Appropriation – Grant Funds – Economic Development – Business Pandemic Relief

1           **WHEREAS**, in accordance with Section 505 of the Cecil County Charter, on April 1, 2019, the County  
2 Executive submitted a proposed budget to the County Council for Fiscal Year 2020; and

3           **WHEREAS**, in accordance with Section 506 of the Cecil County Charter, the County Council held  
4 public hearings on the proposed budget submitted by the County Executive for Fiscal Year 2020; and

5           **WHEREAS**, in accordance with Section 507(b) of the Cecil County Charter, on June 4, 2019, the  
6 Budget for Cecil County was adopted for Fiscal Year 2020; and

7           **WHEREAS**, the County Executive is revising the Fiscal Year 2020 Special Revenue Other Grants Fund  
8 – Office of Economic Development revenue estimate for Cecil County to establish the following amount:  
9 the addition of \$5,000 in grant revenue and expense to the Special Revenue Other Grants Fund – Office of  
10 Economic Development grants operating budget to assist small businesses that have been adversely  
11 affected by the COVID-19 pandemic.

12           **NOW THEREFORE, BE IT HEREBY RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY,**  
13 **MARYLAND**, that the Annual Budget and Appropriation Ordinance for Cecil County, Maryland for Fiscal  
14 Year 2020 is hereby amended for the supplemental appropriation and by amending the Current Budget to  
15 appropriate \$5,000 in additional expenditures in the Special Revenue Other Grants Fund – Office of  
16 Economic Development to record the grant from Baltimore Gas and Electric to provide county-  
17 administered business pandemic relief funds to assist small businesses that have been challenged by the  
18 economic hardships of the COVID-19 response.

19           **AND BE IT FURTHER RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND**, that this  
20 Resolution shall take effect on the date of its passage.
