Title of Resolution: Supplemental Appropriation – Fund Balance – Doctor Jack Road Bridge

Synopsis: A Resolution to amend the Annual Budget and Appropriation Ordinance for Cecil County, Maryland for the fiscal year ending June 30, 2021 in order to provide the Department of Public Works – Roads Maintenance Department within the General Fund, additional expenditure appropriation authority in the amount of \$200,000. The additional expenditure authority will provide the necessary funding to rehabilitate Bridge CE-0003 Doctor Jack Road over Octoraro Creek, due to recent and continuing damage to the structure.

Supplemental Appropriation – Fund Balance – Doctor Jack Road Bridge

1 **WHEREAS**, in accordance with Section 505 of the Cecil County Charter, on April 1, 2020, the County
2 Executive submitted a proposed budget to the County Council for Fiscal Year 2021; and

3 **WHEREAS**, in accordance with Section 506 of the Cecil County Charter, the County Council held
4 public hearings on the proposed budget submitted by the County Executive for Fiscal Year 2021; and

5 **WHEREAS**, in accordance with Section 507(b) of the Cecil County Charter, on May 19, 2020, the
6 Budget for Cecil County was adopted for Fiscal Year 2021; and

7 **WHEREAS**, the County Executive is revising the Fiscal Year 2021 revenue estimate for Cecil County
8 to allocate \$200,000 from the budget Stabilization Reserve Fund to allow the following appropriation
9 within the General Fund: The addition of \$200,000 in expenditure authority for the Department of Public
10 Works – Roads Maintenance Department to go towards rehabilitating the bridge on Doctor Jack Road over
11 Octoraro Creek. The approach steel w-beam connecting to the bridge on the northwest corner at the
12 intersection of Doctor Jack Road and Rowlandsville Road has experienced continued re-occurring impacts
13 from trucks, most recently during the second week of June, 2020. The bridge approach is in need of a long
14 term repair solution that will reduce the reoccurring costs and time County forces spend addressing impact
15 damages; and

16 **WHEREAS**, such appropriation is necessary to provide \$200,000 of fund balance from the Budget
17 Stabilization Reserve Fund for expenditures.

18 **NOW THEREFORE, BE IT HEREBY RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY,**
19 **MARYLAND**, that the Annual Budget and Appropriation Ordinance for Cecil County, Maryland for Fiscal
20 Year 2021 is hereby amended and a supplemental appropriation to the Current Budget in the amount of
21 \$200,000 to the Department of Public Works – Roads Maintenance Department budget within the General
22 Fund in order to provide expenditure authority to rehabilitate Bridge CE-0003 Doctor Jack Road over
23 Octoraro Creek.

24 **AND BE IT FURTHER RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND**, that this
25 Resolution shall take effect on the date of its passage.
