The additional expenditure authority will provide the necessary funding to rehabilitate Bridge CE-0003 Doctor Jack Road over Octoraro Creek, due to recent and continuing damage to the structure.

1	WHEREAS, in accordance with Section 505 of the Cecil County Charter, on April 1, 2020, the County
2	Executive submitted a proposed budget to the County Council for Fiscal Year 2021; and
3	WHEREAS, in accordance with Section 506 of the Cecil County Charter, the County Council held
4	public hearings on the proposed budget submitted by the County Executive for Fiscal Year 2021; and
5	WHEREAS, in accordance with Section 507(b) of the Cecil County Charter, on May 19, 2020, the
6	Budget for Cecil County was adopted for Fiscal Year 2021; and
7	WHEREAS, the County Executive is revising the Fiscal Year 2021 revenue estimate for Cecil County
8	to allocate \$200,000 from the budget Stabilization Reserve Fund to allow the following appropriation
9	within the General Fund: The addition of \$200,000 in expenditure authority for the Department of Public
10	Works – Roads Maintenance Department to go towards rehabilitating the bridge on Doctor Jack Road over
11	Octoraro Creek. The approach steel w-beam connecting to the bridge on the northwest corner at the
12	intersection of Doctor Jack Road and Rowlandsville Road has experienced continued re-occurring impacts
13	from trucks, most recently during the second week of June, 2020. The bridge approach is in need of a long
14	term repair solution that will reduce the reoccurring costs and time County forces spend addressing impact
15	damages; and
16	WHEREAS, such appropriation is necessary to provide \$200,000 of fund balance from the Budget
17	Stabilization Reserve Fund for expenditures.
18	NOW THEREFORE, BE IT HEREBY RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY,
19	MARYLAND, that the Annual Budget and Appropriation Ordinance for Cecil County, Maryland for Fiscal
20	Year 2021 is hereby amended and a supplemental appropriation to the Current Budget in the amount of
21	\$200,000 to the Department of Public Works – Roads Maintenance Department budget within the General
22	Fund in order to provide expenditure authority to rehabilitate Bridge CE-0003 Doctor Jack Road over
23	Octoraro Creek.
24	AND BE IT FURTHER RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND, that this
25	Resolution shall take effect on the date of its passage.
