Amendment – Solid Waste Management Plan 2016-2025

1 WHEREAS, §9-503(a) of the Environment Article of the Annotated Code of Maryland requires the 2 County to prepare a Solid Waste Management Plan that covers at least a 10-year period; and 3 WHEREAS, the Solid Waste Management Plan defines Cecil County's solid waste management 4 goals and objectives, assesses the adequacy of existing solid waste management systems within the 5 County, and presents proposed plans to address the County's long-term solid waste management needs 6 based on projected population growth; and 7 WHEREAS, said plan shall be revised when requested by Maryland Department of the 8 Environment or to include the installation or extension of a solid waste acceptance facility or solid waste 9 disposal system as required by Title 26.03.05 of the Code of Maryland Annotated Regulations (COMAR); 10 and 11 WHEREAS, an amendment to Chapter 3 and Table III-2 of the Solid Waste Management Plan 2016-12 2025 has been proposed to comply with the requirements of Title 26.03.05 of the Code of Maryland Annotated Regulations (COMAR); and 13 14 WHEREAS, an amendment has been proposed for the addition of an Office Building Recycling 15 Program as Chapter 10 to the Recycling Plan 2016-2025, included as an Appendix 1 to the Solid Waste 16 Management Plan, to comply with the requirements of Senate Bill 370 that passed during the 2019 17 legislative session of the Maryland General Assembly; and 18 WHEREAS, proposed plan meets all requirements of Title 26.03.03 of the Code of Maryland 19 Annotated Regulations (COMAR); and 20 WHEREAS, the amended Solid Waste Management Plan 2016-2025, along with the amended 21 Recycling Plan 2016-2025 is provided as Appendix 1 of this Resolution. 22 NOW THEREFORE BE IT RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND, that the proposed amendments to the Solid Waste Management Plan 2016-2025 and associated amended 23 24 Recycling Plan 2016-2025 for Cecil County, Maryland are approved and adopted. 25 AND BE IT FURTHER RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND, that the
