1           **WHEREAS**, in accordance with Section 505 of the Cecil County Charter, on April 1, 2020, the County  
2 Executive submitted a proposed budget to the County Council for Fiscal Year 2021; and

3           **WHEREAS**, in accordance with Section 506 of the Cecil County Charter, the County Council held  
4 public hearings on the proposed budget submitted by the County Executive for Fiscal Year 2021; and

5           **WHEREAS**, in accordance with Section 507(b) of the Cecil County Charter, on May 19, 2020 the  
6 County Council adopted the budget for Fiscal Year 2021; and

7           **WHEREAS**, the States’ Attorney of Cecil County department budget for Fiscal Year 2021 includes  
8 funding to purchase Westlaw Edge Software to be used by the attorneys working for the Office of the State’s  
9 Attorney as well as the County Attorney (County Attorney’s department budget is responsible for \$300 of  
10 the monthly subscription price); and

11           **WHEREAS**, Thomson Reuters West Publishing Corp. has agreed to offer the County a three-year  
12 agreement to purchase 21 subscriptions of the Westlaw Edge Software Primary subscription as well as the  
13 State and Municipal Analytics for Governments for a total payment of \$52,218 over three years (\$1,407.84  
14 per month with a 3% year over year increase); and

15           **WHEREAS**, the proposed subscription agreement is in excess of \$20,000.00 aggregate, and is for  
16 multiple fiscal years, for which County Council approval is required in accordance with Section 515(d) of the  
17 Cecil County Charter; and

18           **WHEREAS**, the County Executive now seeks County Council approval of the aforementioned three (3)  
19 year subscription agreement with Thomson Reuters West Publishing Corp.

20           **NOW THEREFORE, BE IT HEREBY RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY,**  
21 **MARYLAND**, that the County Executive is authorized to enter into a three (3) year agreement with Thomson  
22 Reuters West Publishing Corp. to purchase Westlaw Edge Software with State and Municipal Analytics  
23 Subscription for a total cost of \$52,218.

24           **BE IT FURTHER RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND**, that all  
25 provisions of the Resolution shall take effect on the date of its passage.
