COUNTY COUNCIL OF CECIL COUNTY WORK SESSION MINUTES July 21, 2020

The County Council of Cecil County met in work session in an online virtual meeting because of the current health crisis and based on the Governor's orders to avoid public meetings. Council Members and presenters participated in this meeting; the public observed the meeting by connecting online at www.ccgov.org/council and selecting "livestream".

Call to Order

The meeting of the County Council of Cecil County of July 21, 2020 was called to order by Council President Meffley at 4:30 p.m.

Roll Call of Council Members

Council President Meffley asked for a roll call of attending Council Members. The Council Manager called the roll and recorded the following Council Members in attendance:

Council President Meffley announced that there were four Council Members present, which constitute a quorum.

Suspension of Rules

Councilman Coutz made a motion to suspend the rules to allow Council Members who are connected to participate and vote in this work session, because of the current health crisis and orders by the Governor to avoid public meetings. The motion was seconded by Vice President Gregory.

Roll Call Vote: Coutz-Y, Miller-Y, Patchell-absent, Gregory-Y, Meffley-Y
The motion was approved by a vote of 4 to 0. Councilman Patchell was absent.

Approval of Minutes

On a motion made by Councilman Coutz, seconded by Vice President Gregory, the Council moved to approve the minutes of the Council work session of July 7, 2020, as presented. Motion was approved by a vote of 4 to 0. Councilman Patchell was absent.

2020 General Election Update

Ruie Lavoie, Election Director, provided an update to the Council regarding plans for the 2020 General Election. Governor Hogan has authorized that all polling places will be open on Election Day, Early Voting will be held from October 22 to 29, 2020 in limited vote centers; and every voter will be sent an application for a ballot to be mailed. Ms. Lavoie reviewed the added cost and need for additional election judges. She also stated that the State Board of Elections had advocated for an all-mail ballot election.
