COUNTY COUNCIL OF CECIL COUNTY LEGISLATIVE SESSION MINUTES LSD 2020-17 August 11, 2020

The County Council of Cecil County met in legislative session in an online virtual meeting because of the current health crisis and based on the Governor's orders to avoid public meetings. Council Members, presenters and members of the public participated in this meeting by going online to www.ccgov.org/council and selecting "livestream".

CALL TO ORDER

The meeting of the County Council of Cecil County of August 11, 2020 was called to order by Council President Meffley at 7:00 p.m.

ROLL CALL OF COUNCIL MEMBERS

Council President Meffley asked for a roll call of attending Council Members. The Council Manager called the roll and recorded the following Council Members in attendance:

Roll Call Vote: Coutz-Present, Miller-Present, Patchell-Present, Gregory-Present, Meffley-Present.

Council President Meffley announced that there were five Council Members present, which constitute a quorum.

SUSPENSION OF RULES

Councilman Coutz made a motion to suspend the rules to allow Council Members who are connected to participate and vote in this legislation session, because of the current health crisis and orders by the Governor to avoid public meetings. The motion was seconded by Vice President Gregory.

Roll Call Vote: Coutz-Y, Miller-Y, Patchell-Y, Gregory-Y, Meffley-Y
The motion was approved by a vote of 4 to 0. Councilman Patchell was absent.

OPENING PRAYER

Councilman Miller introduced Rev. Phil Meekins from Monarch Recovery Ministries in North East, who led the opening prayer.

APPROVAL OF AGENDA

On motion made by Councilman Coutz, seconded by Vice President Gregory, the Council moved to approve the legislative agenda of August 11, 2020. Motion was unanimously approved.

PUBLIC HEARINGS

Council Manager Massey stated for the record:

Rezoning Case #2020-03 APPLICANT: 109-111 Providence Road. REQUEST: Request to rezone 0.7 acres from Rural Residential (RR) to Northern Agricultural Residential (NAR); LOCATION: 109-111 Providence Road, Elkton, MD 21921. Election District: 4, Tax Map: 13, Parcel: 360. PROPERTY OWNER: 109-111 Providence Road, LLC (Dave Fennimore). PRESENTLY ZONED Rural Residential, (RR)

Notice of the public hearing was published on July 22, 2020 and July 29, 2020.

Witnesses presenting testimony were sworn in by the Council Manager. Tom Prevas, applicant,

Mr. Prevas, applicant, presented his request for rezoning, based on a mistake in the Comprehensive Rezoning of May 1, 2011. Mr. Prevas' application included a site plan and county zoning map of the area. Exhibit A includes the Council's notice and final decision in rezoning case #2019-05. Exhibit B includes correspondence from the United States Environmental Protection Agency, Region III stating that they do not have any objections to the proposed rezoning. Exhibit C includes correspondence from Victor Jackson, Council Attorney, dated May 29, 2020, that provides a legal opinion that parcel #360 was not approved by the Council in the original rezoning case #2019-05 and his suggestion that the applicant file a new request to rezone parcel #360.

Eric Sennstrom, Director of Land Use and Development Services, stated that the Planning and Zoning staff and Planning Commission had recommended approval based on a demonstrated mistake in the Comprehensive Rezoning. He also presented the staff report of findings of facts, which recommended approval based on a mistake in the Comprehensive Rezoning.

There were no Council questions or Comments.

Council President Meffley opened the public hearing for public comments. There were no public comments.

There were no closing remarks.

Council President Meffley concluded the public hearing and announced that the rezoning case will be considered at the next legislative session on August 18, 2020.

A Bill to amend Chapter 70 (Officers and Employees), Article II, of the Cecil County Code, pursuant to authority set forth in the Annotated Code of Maryland, to now include the labor organization

representing certain Law Enforcement Deputy Sheriffs in the Cecil County Sheriff's Office, Correctional Deputy Sheriffs in the Cecil County Sheriff's Office, and full-time, regular, non-exempt uniformed employees on the Public Safety pay scale within the Cecil County Department of Emergency Services at the rank of captain and below, formulation of a memorandum of understanding of agreements made pursuant to collective bargaining, and dispute resolution procedures, timeframes and rules for conducting non-binding arbitration where the County and a bargaining unit are unable to reach an agreement on the contents of a memorandum of understanding or collective bargaining agreement through mediation, as well as rules for remedying unfair labor practices.

Council President Meffley asked for the Amendments to this legislative be read into the record.

AMENDMENT NO. 3 TO BILL NO. 2020-09

Synopsis: To add an appendix that addresses the procedure for collective bargaining for the Division of Emergency Medical Services.

The Bill was introduced on July 7, 2020, advertised on July 22, 2020 and July 29, 2020, and scheduled for public hearing on August 4, 2020, and postponed to August 11, 2020.

Council President Meffley opened the public hearing for public comment. There were no public comments.

Council President Meffley concluded the public hearing on Bill No. 2020-09 and announced that final consideration of this legislation will be held on August 18, 2020.

PRESIDENT AND COUNCIL COMMENTS

Vice President Gregory provided her comments during the work session.

Councilman Coutz commended the first responders and law enforcement for their heroic work in savinand helping residents during the flooding caused by the hurricane. He also announced that Governor Hogan had declared August as National Immunization Awareness Month and encouraged our community to ensure that children receive their vaccinations before school begins.

Councilman Miller commended the volunteers at the Five Star event this weekend, which included many farmers who helped make the event so successful.

Council President Meffley commended the first responders for their work in assisting citizens who were affected by the storm. He stated that Elkton had serious flooding and many roads closed. He commended Delmarva Power for their prompt response to outages. He stated that the Paris Foundation had flooded and hoped they would recover fast. He also announced that the Upper Shore Regional Council is receiving the same funding as in FY 2020. He stated that Emergency Operations should have provided more information and warning about weather conditions and services during the hurricane.
