## COUNTY COUNCIL OF CECIL COUNTY LEGISLATIVE SESSION MINUTES LSD 2020-18 August 18, 2020

The County Council of Cecil County met in legislative session in an online virtual meeting because of the current health crisis and based on the Governor's orders to avoid public meetings. ## **CALL TO ORDER**

The meeting of the County Council of Cecil County of August 18, 2020 was called to order by Council President Meffley at 7:00 p.m. Council President Meffley led the audience in the Pledge of Allegiance.

## **ROLL CALL OF COUNCIL MEMBERS**

Council President Meffley asked for a roll call of attending Council Members. The Council Manager called the roll and recorded the following Council Members in attendance:

Roll Call Vote: Coutz-Present, Miller-Present, Patchell-Present, Gregory-Present, Meffley-Present.

Council President Meffley announced that there were five Council Members present, which constitute a quorum.

## **SUSPENSION OF RULES**

Councilman Coutz made a motion to suspend the rules to allow Council Members who are connected to participate and vote in this legislation session, because of the current health crisis and orders by the Governor to avoid public meetings. The motion was seconded by Vice President Gregory.

## **OPENING PRAYER**

Councilman Miller introduced Reverend David Burke from Mt. Pleasant United Methodist Church in Colora, who led the opening prayer.

#### **APPROVAL OF AGENDA**

On motion made by Councilman Coutz, seconded by Vice President Gregory, the Council moved to approve the legislative agenda of August 18, 2020. Motion was unanimously approved.

## PRESENTATION OF PROCLAMATIONS/CERTIFICATES

Council President Meffley announced that the Council and administration will present a proclamation to Chief Matthew Donnelly, Elkton Police Chief, who will be retiring after thirty-one years of service. Council President Meffley will present at Chief Donnelly's final walk-out on August 27, 2020.

#### **APPROVAL OF MINUTES**

On motion made by Councilman Coutz, seconded by Vice President Gregory, the Council moved to approve the minutes of the legislative session of August 11, 2020. Motion was approved unanimously.

#### **PUBLIC COMMENTS**

Harold McCanick, Elk Neck, stated that August 19, 2020 is National Aviation Day.

## PRESIDENT AND COUNCIL COMMENTS

Vice President Gregory had no comments.

Councilman Coutz thanked Mr. Moyer and Ms. Edwards for their presentation on enterprise zones at the work session. He also expressed his best wishes to Mr. Moyer who has accepted a new position at Evergreen Investment. He also commented on the Sheriff's Office intel meeting where drug and violent crime statistics remain the same. He asked the community to help their neighbors.

Councilman Patchell commented on the importance of broadband for students while schools are closed for the pandemic. He stated that Governor Hogan announced that \$10M was available to help expand broadband in rural communities. He also wished Chris Moyer good luck in his new position.

Councilman Miller attended the Cecil County Firemen's Association and commented about emergency responses to the flooding. He thanked Rev. Willie Walton for presenting photo albums of forty-five years of fire service in Cecil County. He also thanked Chris Moyer for his service to Cecil County and wished him well at his new position. He stated the need for broadband in the Calvert community.

Council President Meffley thanked Chris Moyer for his service to Cecil County. He stated that he had worked with citizens on many complaints regarding vandalism, flooding, and parking and road conditions. He stated that he enjoys helping citizens with their problems.

A Resolution to amend the Annual Budget and Appropriation Ordinance for Cecil County, Maryland for the fiscal year ending June 30, 2021, in order to provide a total of \$16,600 to the Special Revenue Other Grants Fund- Department of Land Use and Development Services to record the grant awarded from the Upper Shore Regional Council for the purpose of bringing internet access to underserved areas of Cecil County.

A Resolution to amend the Annual Budget and Appropriation Ordinance for Cecil County, Maryland for the fiscal year ending June 30, 2021 in order to provide Cecil College additional General Fund expenditure appropriation authority in the amount of \$85,000. The additional expenditure authority will provide the necessary funding to relocate Cecil College's transportation training facility and operational grounds to a different location on the property owned by the Bainbridge Development Corporation.

A Bill to amend Chapter 70 (Officers and Employees), Article II, of the Cecil County Code, pursuant to authority set forth in the Annotated Code of Maryland, to now include the labor organization representing certain Law Enforcement Deputy Sheriffs in the Cecil County Sheriff's Office, Correctional Deputy Sheriffs in the Cecil County Sheriff's Office, and full-time, regular, non-exempt uniformed employees on the Public Safety pay scale within the Cecil County Department of Emergency Services at the rank of captain and below, formulation of a memorandum of understanding of agreements made pursuant to collective bargaining, and dispute resolution procedures, timeframes and rules for conducting non-binding arbitration where the County and a bargaining unit are unable to reach an agreement on the contents of a memorandum of understanding or collective bargaining agreement through mediation, as well as rules for remedying unfair labor practices.

**Synopsis:** To add an appendix that addresses the procedure for collective bargaining for the Division of Emergency Medical Services.

The Bill was introduced on July 7, 2020, advertised on July 22, 2020 and July 29, 2020, and scheduled for public hearing on August 4, 2020, and postponed to August 11, 2020. Final consideration was postponed until August 18, 2020.
