RESOLUTION NO. 02-2021
Supplemental Appropriation – Grant Funds – MARBIDCO – Micro Ag Grant Program

1 **WHEREAS**, in accordance with Section 505 of the Cecil County Charter, on April 1, 2020, the County
2 Executive submitted a proposed budget to the County Council for Fiscal Year 2021; and

3 **WHEREAS**, in accordance with Section 506 of the Cecil County Charter, the County Council held
4 public hearings on the proposed budget submitted by the County Executive for Fiscal Year 2021; and

5 **WHEREAS**, in accordance with Section 507(b) of the Cecil County Charter, on May 19, 2020, the
6 Budget for Cecil County was adopted for Fiscal Year 2021; and

7 **WHEREAS**, the County Executive is revising the Fiscal Year 2021 Special Revenue Other Grants Fund
8 Office of Economic Development revenue estimate for Cecil County to establish the following amount: the
9 addition of \$14,000 in grant revenue and expense to the Special Revenue Other Grants Fund – Office of
10 Economic Development budget to provide for the cost share grant program from the MARBIDCO awarded
11 to Cecil County; and

12 **WHEREAS**, such appropriation is necessary to provide \$14,000 in program funding as a source of
13 matching funds for the Micro-Ag Grant Program. The goal of the program is to foster growth in Maryland’s
14 existing and emerging agricultural and resource-based businesses by working with local and regional
15 economic development offices. These matching grants are provided to local and regional economic
16 development entities to co-fund significant agricultural projects.

17 **NOW THEREFORE, BE IT HEREBY RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY,**
18 **MARYLAND**, that the Annual Budget and Appropriation Ordinance for Cecil County, Maryland for Fiscal
19 Year 2021 is hereby amended for the supplemental appropriation and by amending the Current Budget to
20 appropriate \$14,000 in additional expenditures in the Special Revenue Other Grants Fund – Office of
21 Economic Development to record the grant awarded from MARBIDCO for the purpose of matching the
22 Micro Ag-Grant program in Cecil County.

23 **BE IT FURTHER RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND**, that all
24 provisions of this Resolution shall take effect on the date of its passage.
