1           **WHEREAS**, pursuant to Section 8-301, Subtitle 3, Title 8 of the Human Services Article of the  
2 Annotated Code of Maryland, each county shall establish and maintain a local management board to  
3 ensure the implementation of a local interagency service delivery system for children, youth, and families,  
4 and

5           **WHEREAS**, pursuant to Section 8-302, a local management board may be composed of public and  
6 private community representatives who share the responsibility for implementing a community-based,  
7 interagency, family-focused service delivery system for children, youth, and families; and

8           **WHEREAS**, pursuant to Section 8-303, a local management board shall strengthen the decision-  
9 making capacity at the local level; design and implement strategies that achieve clearly defined results for  
10 children, youth, and families; maintain standards of accountability for locally agreed upon results;  
11 influence the allocation of resources across the system; build local partnerships to coordinate services;  
12 and create an effective system of services, supports, and opportunities that improve outcomes for all; and

13           **WHEREAS**, the Local Management Board in Cecil County is known as the Human Services Agency;  
14 and

15           **WHEREAS**, Article 4, Section 412 (b) of the Charter of Cecil County provides that the County  
16 Executive shall appoint all members of boards and commissions, subject to confirmation by the Council;  
17 and

18           **WHEREAS**, the County Executive has recommended David Trolio for reappointment to the Cecil  
19 County Human Services Agency, to a two year term, which is to expire on February 2, 2023.

20           **NOW, THEREFORE, BE IT HEREBY RESOLVED THAT THE COUNTY COUNCIL OF CECIL COUNTY,**  
21 **MARYLAND**, confirms the recommendation by the County Executive of David Trolio for reappointment to  
22 the Cecil County Human Services Agency, to a two year term, which is to expire on February 2, 2023.

23           **BE IT FURTHER RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND**, that this  
24 Resolution shall take effect on the date of its passage.
