1	WHEREAS, in accordance with Section 505 of the Cecil County Charter, on April 1, 2020, the
2	County Executive submitted a proposed budget to the County Council for Fiscal Year 2021; and
3	WHEREAS, in accordance with Section 506 of the Cecil County Charter, the County Council held
4	public hearings on the proposed budget submitted by the County Executive for Fiscal Year 2021; and
5	WHEREAS, in accordance with Section 507(b) of the Cecil County Charter, on May 19, 2020, the
6	Budget for Cecil County was adopted for Fiscal Year 2021; and
7	WHEREAS, the County Executive is revising the Fiscal Year 2021 revenue estimate for Cecil County
8	to increase use of the Assigned Fund Balance for Volunteer Fire Company Vehicle Replacement by
9	\$250,000, to allow the following appropriation within the General Fund: the addition of \$250,000 in
10	expenditures for the Volunteer Fire Service Vehicle Replacement Program. The FY2021 Approved Budget
11	for the replacement program was funded in the amount of \$575,000. There were additional equipment
12	replacement requests submitted for FY2021 that were not funded, but in need of replacement. The
13	County Executive decided to assign fund balance when the FY2020 financials were completed and funds
14	were available to partially fund the FY2021 request; and
15	WHEREAS, such appropriation is necessary to provide \$250,000 of the County Executive's FY2020
16	assigned fund balance for the General Fund for expenditures.
17	NOW THEREFORE, BE IT HEREBY RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY,
18	MARYLAND, that the Annual Budget and Appropriation Ordinance for Cecil County, Maryland, for Fiscal
19	Year 2021 is hereby amended for the supplemental appropriation; and by amending the Current Budget
20	to appropriate \$250,000 of additional expenditures in the General Fund to the Volunteer Fire Service
21	Department's budget.

23	that this Resolution shall take effect on the date of its passage.
