- Looking for EDC members to serve as advocates; use as sounding boards for OED programs, concepts, initiatives
- OED will take very customer focused approach to economic development, being responsive and engaged with business community; agriculture will play a crucial role in diversifying economy
- COVID has taken major toll on some small businesses; others have thrived due to pivoting their business models
- Looking at growth and attraction opportunities for all new and existing businesses
- Provide full support of agribusiness in County
- Continue Tourism excellence
- Forge partnerships with extended business teams to better serve businesses
- Administering grants
 - Original CARES money assisted 546 applicants = \$4.9M
 - December 31 deadline met; since extended
 - Have received additional funds Hotel grants \$267K; Restaurant grants \$398K
 - Hoping to expand footprint to include bed and breakfasts and restaurant criteria
- Looking at ways to infuse technology into farming community to create new business opportunities
- Launched Upper Shore Micro Ag Grant will run Jan. 1-31, grants of \$250-\$5,000
- Ag symposium (virtual), "Rooted in Our Community", March 2021, info to follow
- Introduce and Welcome Jayci Mitchell, ag intern, to OED
 - Senior at North East High and SSCT in X Science Program
 - Serve as Future Farmers of America President
 - President of 4-H Club
 - Actively involved in Cecil County Fair Board
 - Thrilled to be helping farmers and to bring more agriculture industry to Cecil
- Tourism will be moving to North East; more centrally located in County
- Winter Lights Cecil Nights
- Encourage folks to come to downtowns to support local businesses thru restaurants, shops, and planned events; runs January February
- Working with Bassmasters to host 2-year event Bassmasters Kayak Fishing Event; Summer of 2021 and Summer of 2022
- Maryland 5 Star at Fair Hill
 - Received confirmed status as 5 Star Event; added to international calendar for next 5 yrs.
