Appointment - Drug and Alcohol Abuse Council - Robert Alt

WHEREAS, the Council shall determine its own governing structure including the appointment of a chair; and

WHEREAS, the Council shall develop and submit a local plan to the Behavior Health Administration of the Maryland Department of Health and Mental Hygiene; and

WHEREAS, the local plan shall include the plans, strategies, and priorities of the county for meeting identified needs of the general public and the criminal justice system for alcohol and drug abuse evaluation, prevention, and treatment services; and

WHEREAS, the local plan shall also include a survey of all federal, State, local and private funds used in the county for alcohol and drug abuse evaluation, prevention and treatment; and

WHEREAS, the County Executive has recommended Robert Alt for appointment to the Cecil County Alcohol and Drug Abuse Council as an individual who is knowledgeable about treatment of substance abuse in the county; to a four-year term which is to expire May 18, 2025.

NOW, THEREFORE, BE IT HEREBY RESOLVED THAT THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND, confirms the recommendation by the County Executive of Robert Alt for appointment to the Cecil County Drug and Alcohol Abuse Council as an individual who is knowledgeable about treatment of substance abuse in the county; to a four-year term, which is to expire on May 18, 2025.

BE IT FURTHER RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND, that all provisions of this Resolution shall take effect on the date that the Resolution is approved.
