1 **WHEREAS**, pursuant to Tax Property Article of the Annotated Code of Maryland, Title 3, Section 3-102
2 there is a property tax assessment appeal board in each county; and

3 **WHEREAS**, pursuant to Tax Property Article, Title 3; Section 3-103(a), the Property Tax Assessment
4 Appeal Board is comprised of three members and one alternate members, who are appointed by the
5 Governor of Maryland, and

6 **WHEREAS**, the Governor appoints the members from a list of names, as submitted by the County
7 Executive with the approval of the County Council; pursuant to Section 3-103(a) and

8 **WHEREAS**, the term of a member is five years and ends on June 1 of the appropriate year, but a
9 member continues to serve until a successor is appointed and qualifies, pursuant to Section 3-103(c)(2); and

10 **WHEREAS**, the Property Tax Assessment Appeal Board has jurisdiction over appeals concerning real
11 property values and assessments, credits for elderly or disabled renters, credits for homeowners, credits for
12 elderly or disabled homeowners, credits for real property leased to a religious group or religious organization,
13 value of agricultural easements, and the rejection of an application for property tax exemption; pursuant to
14 Section 3-107(a); and

15 **WHEREAS**, pursuant to Section 412(b) of the Charter of Cecil County, the Executive shall appoint all
16 members of boards and commissions and that such membership shall be subject to confirmation by the
17 Council; and

18 **WHEREAS**, Dale K. DeWeese was appointed as an alternate member of the Cecil County Property Tax
19 Assessment Appeal Board in February 19, 2019, to a five-year term to expire on June 1, 2024; and

20 **WHEREAS**, the County Executive has recommended Dale K. DeWeese for appointment as a member of
21 the Cecil County Property Tax Assessment Appeal Board, to a five-year term, which is to expire on
22 June 1, 2026.

23 **NOW, THEREFORE, BE IT HEREBY RESOLVED THAT THE COUNTY COUNCIL OF CECIL COUNTY,**
24 **MARYLAND**, confirms the recommendation by the County Executive of Dale K. DeWeese for appointment as
25 member of the Cecil County Property Tax Assessment Appeal Board, to a five-year term, which is to expire on
26 June 1, 2026.

27 **AND BE IT FURTHER RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND**, that this
28 Resolution shall take effect on the date of its passage.
