Title of Bill: Transfer of Appropriations – Board of Education Capital Budget – FY 2022 to FY 2021

Synopsis: A Bill to amend the Annual Budget and Appropriation Ordinance for Cecil County, Maryland, for the fiscal year ending June 30, 2021, to move forward the bond expenditure authority in the amount of \$4,200,000, requested for the New Chesapeake City Elementary School within the Board of Education Capital Projects Budget, resulting in a reduction to FY2022 and increase to the current fiscal year 2021.

Transfer of Appropriations – Board of Education Capital Budget – FY 2022 to FY 2021

1 **WHEREAS**, in accordance with Section 505 of the Cecil County Charter, on April 1, 2020,
2 the County Executive submitted a proposed budget to the County Council for Fiscal Year 2021; and

3 **WHEREAS**, in accordance with Section 506 of the Cecil County Charter, the County Council
4 held public hearings on the proposed budget submitted by the County Executive for Fiscal Year
5 2021; and

6 **WHEREAS**, in accordance with Section 507(b) of the Cecil County Charter, on May 19, 2020
7 the County Council adopted the budget for Fiscal Year 2021; and

8 **WHEREAS**, the County Executive is revising the Fiscal Year 2021 Board of Education Capital
9 Projects Budget to move bond revenue and expenditure authority from FY2022 to the current
10 2021 fiscal year for the New Chesapeake City Elementary School project. The project is ahead of
11 schedule and in its final phase of construction. The project will need the funds to complete the
12 project ahead of the original cash flow schedule developed at the start of the project; and

13 **WHEREAS**, Section 506 of the Charter of Cecil County requires that no final budget action
14 may be taken by the County Council until after public hearing or hearings have been held in open
15 public session.

16 **NOW, THEREFORE, BE IT RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY,**
17 **MARYLAND**, that the Annual Budget and Appropriation Ordinance for Cecil County, Maryland for
18 Fiscal Year 2021 is hereby amended to move forward the bond expenditure authority in the
19 amount of \$4,200,000, requested for the New Chesapeake City Elementary School within the
20 Board of Education Capital Projects Budget, resulting in a reduction to FY2022 and increase to the
21 current fiscal year 2021.

22 **AND IT IS FURTHER ENACTED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND,**
23 that this Bill shall take effect 60 calendar days from the date that it becomes law.
