Synopsis: A Bill to amend the Annual Budget and Appropriation Ordinance for Cecil County, Maryland, for the fiscal year ending June 30, 2021 to transfer existing bond appropriation authority within the Board of Education Capital Projects Budget, in the amount of \$308,706.71 from the New Gilpin Manor Elementary School completed project, to the preliminary design work for the new North East Middle School.

Transfer of Appropriations – Board of Education Capital Budget – North East Middle School

1 **WHEREAS**, in accordance with Section 505 of the Cecil County Charter, on April 1, 2020,
2 the County Executive submitted a proposed budget to the County Council for Fiscal Year 2021; and

3 **WHEREAS**, in accordance with Section 506 of the Cecil County Charter, the County Council
4 held public hearings on the proposed budget submitted by the County Executive for Fiscal Year
5 2021; and

6 **WHEREAS**, in accordance with Section 507(b) of the Cecil County Charter, on May 19, 2020
7 the Budget for Cecil County was approved for Fiscal Year 2021; and

8 **WHEREAS**, the County Executive is revising the Fiscal Year 2021 Board of Education Capital
9 Projects Budget to transfer the unencumbered bond revenue and expense for Cecil County,
10 Maryland remaining after the completion of the New Gilpin Manor Elementary School of
11 \$308,706.71 due to the project finishing under budget; and

12 **WHEREAS**, such appropriation of unencumbered bond revenue and expense totaling
13 \$308,706.71 is requested to be transferred to the New North East Middle School Project to
14 facilitate preliminary design on the project; and

15 **WHEREAS**, Section 506 of the Charter of Cecil County requires that no final budget action
16 may be taken by the County Council until after public hearing or hearings have been held in open
17 public session.

18 **NOW THEREFORE, BE IT HERBY RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY,**
19 **MARYLAND**, that the Annual Budget and Appropriation Ordinance for Cecil County, Maryland for
20 Fiscal Year 2021 is hereby amended for the supplemental appropriation, and by amending the
21 Budget to appropriate the transfer of existing bond appropriation authority within the Board of
22 Education Capital Projects Budget, in the amount of \$308,706.71 from the Gilpin Manor
23 Elementary School completed project, to the New North East Middle School Project.

24 **AND IT IS FURTHER ENACTED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND,**
25 that this Bill shall take effect 60 calendar days from the date that it becomes law.
