1           **WHEREAS**, pursuant to the Human Services Article of the Annotated Code of Maryland, Title 3.  
2 Local Departments of Social Services, Subtitle 5. Local Boards, Section 3-503, defines the duties and  
3 functions of a local Social Services Board as an advisory board to the local director for the local application  
4 and implementation of State policies or procedures, which includes evaluating and making  
5 recommendations to improve current services and develop new services as needed in the county; and  
6 serving as the liaison with the local government authority and residents to communicate the objectives,  
7 policies and programs of local social services and public assistance administration; and

8           **WHEREAS**, Article 4, Section 412 (b) of the Charter of Cecil County provides that the County  
9 Executive shall appoint all members of boards and commissions, subject to confirmation by the Council;  
10 and

11           **WHEREAS**, the County Executive has recommended Robert F. McKnight, Sr., for appointment to  
12 the Department of Social Services Board for a three (3) year term which is to expire on June 1, 2024.

13           **NOW, THEREFORE, BE IT HEREBY RESOLVED THAT THE COUNTY COUNCIL OF CECIL COUNTY,**  
14 **MARYLAND**, confirms the recommendation by the County Executive of Robert F. McKnight, Sr., to the  
15 Department of Social Services Board for a three (3) year term, which is to expire on June 1, 2024.

16           **AND BE IT FURTHER RESOLVED** that this Resolution shall take effect on the date of its passage by  
17 the County Council of Cecil County, Maryland.
