2	the County Executive submitted a proposed budget to the County Council for Fiscal Year 2021; a		
3	WHEREAS, in accordance with Section 506 of the Cecil County Charter, the County Counc		
4	held public hearings on the proposed budget submitted by the County Executive for Fiscal Year		
5	2021; and		
6	WHEREAS, in accordance with Section 507(b) of the Cecil County Charter, on May 19, 2020		
7	the Budget for Cecil County was approved for Fiscal Year 2021; and		
8	WHEREAS, the County Executive is revising the Fiscal Year 2021 Board of Education Capita		
9	Projects Budget to transfer the unencumbered bond revenue and expense for Cecil County,		
10	Maryland remaining from the following completed and awarded School Capital Projects:		
11	a) To transfer \$95,364.20 from the completed Bohemia Manor High Roof Replacement		
12	Project; and		
13	b) To transfer \$1,471.00 from the completed Providence School Roof Replacement		
14	Project; and		
15	c) To transfer \$3,993.00 from the completed Rising Sun Elementary Boiler Replacement		
16	Project; and		
17	d) To transfer \$60.26 from the completed Cherry Hill Middle School Windows and Doors		
18	Project; and		
19	WHEREAS, such appropriation of unencumbered bond revenue and expense totaling		
20	\$100,888.46 is requested to be transferred to the New Chesapeake Elementary School Project to		
21	facilitate the current construction project schedule; and		
22	WHEREAS, Section 506 of the Charter of Cecil County requires that no final budget action		
23	may be taken by the County Council until after public hearing or hearings have been held in open		
24	public session.		
25	NOW THEREFORE, BE IT HEREBY RESOLVED that the Annual Budget and Appropriation		
26	Ordinance for Cecil County, Maryland, for Fiscal Year 2021 is hereby amended for the		
27	supplemental appropriation, and by amending the Budget to appropriate the transfer of bond		
28	appropriations, within the Board of Education Capital Projects Fund, in the amount of \$100,888.4		
29	from completed School Capital Projects (Bohemia Manor High Roof Replacement Project
