Open Meeting Minutes

April 20, 2021

Call to Order:

Lawrence Scott called the meeting to order at 5:00 pm.

- Acknowledgement of Understanding Statement reviewed by all Commission members.
- Lawrence Scott provided the original County Executive Commission Appointment Letters to each member.

2021 Chair Election:

- Charles Kelso nominated Andrew Goins
 - Heather O'Rourke made a motion to elect Andrew Goins as the 2021 Ethics Commission Chair, seconded by Charles Kelso, approved by all.

Agenda Approval:

 Andrew Goins made a motion to approve the draft 4/20/2021 agenda, seconded by Charles Kelso, and approved by all.

November 9, 2020 Meeting Minutes Approval:
