1           **WHEREAS**, the County Executive of Cecil County desires to not have a backlog of unrealized  
2 residential wastewater connection entitlement that threaten the County’s limited wastewater resources  
3 and to align residential, commercial, and industrial classification sewer systems; and

4           **WHEREAS**, pursuant to section 365-38 of the County Code of Cecil County the County reserves the  
5 right to regulate sewer user rates; and

6           **WHEREAS**, pursuant to Section 365-1 of the Cecil County Code, all County areas to be served with  
7 water and sewer are under the authority of the Department of Public Works; and

8           **WHEREAS**, pursuant to Section 365-35 of the Cecil County Code, the County may require payment  
9 of a connection fee as a condition precedent to connection to County sewer mains; and

10           **WHEREAS**, pursuant to Section 365-36 of the Cecil County Code, all persons who connect to County  
11 sewer shall in fact pay, in addition to all other charge state, a connection fee and/or benefit charge, the  
12 specific amount and condition to be set in a sewer user regulation which has been or will be enacted by the  
13 Cecil County Council; and

14           **WHEREAS**, on July 18, 2017, the County Council adopted Resolution 31-2017, thereby establishing  
15 the current residential wastewater connection charge; and

16           **WHEREAS**, the County Executive requests introduction and passage of this Resolution to amend  
17 that the determination of the wastewater connection charge from a valid subdivision proposal or approval  
18 to be at the time of issuance of a valid building permit; and

19           **NOW, THEREFORE, BE IT HEREBY RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY,**  
20 **MARYLAND**, that the determination of the wastewater fee shall be completed at the of building permit  
21 issuance.

22           **AND, BE IT FURTHER RESOLVED THAT** this resolution shall take effect on the date of its passage by  
23 the County Council of Cecil County, Maryland.
