1           **WHEREAS**, the Bainbridge Development Corporation was established as a regional development  
2 unit of the State in support of military installations, pursuant to Economic Development Article, Division II.  
3 Independent and Regional Development Units and Resources, Title 11: Military Installations Support,  
4 Subtitle 4: Bainbridge Development Corporation, Section 11-402; and

5           **WHEREAS**, the Bainbridge Development Corporation was established to plan, initiate and oversee  
6 the activities necessary to convert the 1,200 acres site, formerly the United States Bainbridge Naval  
7 Training Center, into re-use opportunities that can maximize the economic contribution from the  
8 redevelopment; and

9           **WHEREAS**, the Board of Directors shall appoint an Executive Director, subject to the approval of  
10 the County Council, formerly County Commissioners, pursuant to Section 11-406(a)(1); and

11           **WHEREAS**, the Executive Director serves at the pleasure of the Board and the Board shall  
12 determine the salary of the Executive Director, pursuant to Section 11-406(b); and

13           **WHEREAS**, the Executive Director shall attend all meetings of the Board, act as secretary of the  
14 Board, keep minutes of the proceedings of the Board, approve salaries, per diem payments, allowable  
15 expenses of the Corporation and its employees or consultants, and any expenses incidental to the  
16 operation of the corporation, pursuant to Section 11-406); and

17           **WHEREAS**, the Board of Directors of the Bainbridge Development Corporation has recommended  
18 Toni Sprenkle as Executive Director through an Inter-Agency agreement with MEDCO; and

19           **WHEREAS**, the Board of Directors of the Bainbridge Development Corporation has requested that  
20 the County Council of Cecil County, Maryland, approve the recommendation of Toni Sprenkle as  
21 Executive Director.

22           **NOW, THEREFORE, BE IT HEREBY RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY,**  
23 **MARYLAND**, confirms the appointment of Toni Sprenkle as the Executive Director of the Bainbridge  
24 Development Corporation.

25           **AND, BE IT FURTHER RESOLVED** that this Resolution will become effective upon its passage by the  
26 County Council of Cecil County.
