Approval – Agreement – Cecil County Corrections Association

1           **WHEREAS**, pursuant to Section 70-5(A) of the Code of Cecil County, the Cecil County Council may  
2 enact an ordinance to authorize recognition of an exclusive representative by election or voluntary  
3 recognition through a check of authorization cards at the County’s option and provide a process for such  
4 authorization; and

5           **WHEREAS**, pursuant to Section 70-5(C) of the Code of Cecil County, the Council may allow  
6 collective bargaining between Cecil County and the exclusive representative of its employees concerning  
7 terms and conditions of employment, and a process to resolve disagreements concerning the  
8 interpretation of any agreement made between the exclusive representative and the County; and

9           **WHEREAS**, pursuant to Section 70-5(D-G) of the Code of Cecil County, the Council may set forth  
10 the subjects of collective bargaining and the rights reserved by the County from those subjects; time  
11 frames of collective bargaining process; rules of conduct for collective bargaining; and a process and  
12 remedies for violations of established rules; and

13           **WHEREAS**, an agreement between Cecil County, Maryland, and Sheriff of Cecil County, and Cecil  
14 County Corrections Association, Local 84 of the International Union of Police Association, to be effective  
15 from July 1, 2021 to June 30, 2025, was approved and signed by all parties on May 18, 2021, and

16           **WHEREAS**, the Agreement between Cecil County, Maryland, and Sheriff of Cecil County and Cecil  
17 County Corrections Association, Local 84 of the International Union of Police Association is attached as  
18 Appendix 1.

19           **NOW THEREFORE, BE IT HEREBY RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY,**  
20 **MARYLAND**, that the Agreement between Cecil County, Maryland, and Sheriff of Cecil County and Cecil  
21 County Corrections Association, Local 84 of the International Union of Police Association, as agreed by all  
22 parties on May 18, 2021 is hereby approved to be effective between July 1, 2021 to June 30, 2025.

23           **AND, BE IT FURTHER RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND**, that  
24 this Resolution shall take effect on the date of its passage.
