1 **WHEREAS**, Section 411 of the Charter of Cecil County provides that the County Attorney shall be the
2 chief legal officer of the County, and be a legal advisor to the Cecil County Council; and

3 **WHEREAS**, the County Executive appointed Lawrence Scott as County Attorney, which was confirmed
4 by the County Council on December 8, 2020; and

5 **WHEREAS**, the County Attorney represents the County Executive, all departments and other
6 instrumentalities of the County Government in Cecil County; and

7 **WHEREAS**, Section 213 of the Charter of Cecil County provides that the County Council may by
8 resolution, at its discretion and subject to the provisions of its budget or supplementary appropriations,
9 employ legal advisors as it deems necessary to perform its functions; and

0 **WHEREAS**, the County Council solicited expressions of interest for an attorney to provide legal services
1 to the County Council; and

2 **WHEREAS**, the Council wishes to appoint Charles MacLeod and MacLeod Law Group, LLC., and
3 Victor R. Jackson, LLC as Council Attorneys.


4 **NOW, THEREFORE, BE IT HEREBY RESOLVED THAT THE COUNTY COUNCIL OF CECIL COUNTY,**
5 **MARYLAND**, designates Charles MacLeod and MacLeod Law Group, LLC, and Victor R. Jackson, LLC as Council
6 Attorneys as of July 1, 2021.

7 **BE IT FURTHER RESOLVED THAT THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND**, that all
8 provisions of this Resolution shall take effect on the date the Resolution is adopted by the Council.

9 **AND BE IT FURTHER RESOLVED THAT THE COUNTY COUNCIL** authorizes the Council President to sign
0 the agreement with Charles MacLeod and MacLeod Law Group, LLC., and Victor R. Jackson, LLC on behalf of
1 the County Council.
