Approval – Agreement – Cecil County Fraternal Order of Police

1 **WHEREAS**, pursuant to Section 70-5(A) of the Code of Cecil County, the Cecil County Council may
2 enact an ordinance to authorize recognition of an exclusive representative by election or voluntary
3 recognition through a check of authorization cards at the County’s option and provide a process for such
4 authorization; and

5 **WHEREAS**, pursuant to Section 70-5(C) of the Code of Cecil County, the Council may allow
6 collective bargaining between Cecil County and the exclusive representative of its employees concerning
7 terms and conditions of employment, and a process to resolve disagreements concerning the
8 interpretation of any agreement made between the exclusive representative and the County; and

9 **WHEREAS**, pursuant to Section 70-5(D-G) of the Code of Cecil County, the Council may set forth
10 the subjects of collective bargaining and the rights reserved by the County from those subjects; time
11 frames of collective bargaining process; rules of conduct for collective bargaining; and a process and
12 remedies for violations of established rules; and

13 **WHEREAS**, an agreement between Cecil County, Maryland, and Sheriff of Cecil County, and Cecil
14 County Lodge 2, Fraternal Order of Police, Inc., to be effective from July 1, 2021 to June 30, 2025, was
15 approved and signed by all parties on September 16, 2021; and

16 **WHEREAS**, the Agreement between Cecil County, Maryland, and Sheriff of Cecil County, and Cecil
17 County Lodge 2, Fraternal Order of Police, Inc., is attached as Appendix 1.

18 **NOW THEREFORE, BE IT HEREBY RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY,**
19 **MARYLAND**, that the Agreement between Cecil County, Maryland, and Sheriff of Cecil County, and Cecil
20 County Lodge 2, Fraternal Order of Police, Inc., as agreed by all parties on September 16, 2021, is hereby
21 approved to be effective between July 1, 2021 to June 30, 2025.

22 **AND, BE IT FURTHER RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND**, that
23 this Resolution shall take effect on the date of its passage.
