**Title of Bill:** Public Schools – Bus Safety - Cameras

**Synopsis:** An Act to amend the Code of Cecil County, Chapter 101 Schools, to add Section 101-3 School Bus Safety Cameras in order to authorize the use of school bus monitoring cameras on school buses in Cecil County; to authorize certain enforcement and to provide that certain violations are a civil penalty; to provide for the use of fines; and generally relating to enforcement of traffic laws in Cecil County.

21	NOW, THEREFORE, BE IT HEREBY ENACTED BY THE COUNTY COUNCIL OF CECIL COUNTY,			
22	MARYLAND, that a new section of the Code of Cecil County, in Chapter 101 to be titled "Section 101-3			
23	School Bus Safety Cameras", under Chapter 101 Schools, is hereby enacted to read as follows:

- 31 5) "School bus safety camera" means a camera placed on a school bus that is designed to
- 32 capture a recorded image of a driver of a motor vehicle committing a violation authorized by
- Annotated Code of Maryland, Transportation Article, Section 21-706.1.
- 34 6) "Schools" means Cecil County Public Schools.
- B. The Board may install, operate, maintain school bus safety cameras on school busses as permitted by
- the Annotated Code of Maryland, Transportation Article, Section 21-706.1.
- 37 C. A person who commits a violation recorded by a school bus safety camera is subject to a civil penalty
- authorized by the Annotated Code of Maryland, Transportation Article, Section 21-706.1.
- 39 D. The registered owner of a motor vehicle will be sent a citation by the Sheriff's Office, which will include
- 40 a fine of \$250 for each violation.
- 41 E. The Schools must use any fines collected by the County for a violation recorded by a school bus safety
- 42 camera:
- 43 1) To recover the costs of installing, operating, and maintaining school bus safety cameras.
- 44 2) For public safety purposes, including pedestrian safety programs.
- 45 AND BE IT FURTHER ENACTED that this Act shall take effect 60 calendar days from the date it
- 46 becomes law.
