**Synopsis:** A Resolution to amend the Annual Budget and Appropriation Ordinance for Cecil County, Maryland, for the fiscal year ending June 30, 2022, in order to provide a total of \$27,000 to the Special Revenue Other Grants Fund- Office of Economic Development, in order to record the grant awarded from the Upper Shore Regional Council, for the purpose of an Agriculture Microgrant Program in Cecil County.

Supplemental Appropriation – Grant Funds – Economic Development –  
Upper Shore Regional Council – Agriculture Microgrant Program

1           **WHEREAS**, in accordance with Section 505 of the Cecil County Charter, on April 1, 2021, the  
2 County Executive submitted a proposed budget to the County Council for Fiscal Year 2022; and

3           **WHEREAS**, in accordance with Section 506 of the Cecil County Charter, the County Council held  
4 public hearings on the proposed budget submitted by the County Executive for Fiscal Year 2022; and

5           **WHEREAS**, in accordance with Section 507(b) of the Cecil County Charter, on June 1, 2021, the  
6 Budget for Cecil County was adopted for Fiscal Year 2022; and

7           **WHEREAS**, the County Executive is revising the Fiscal Year 2022 Special Revenue Other Grants  
8 Fund – Office of Economic Development revenue estimate for Cecil County to establish the following  
9 amount: the addition of \$27,000 in grant revenue and expense to the Special Revenue Other Grants Fund  
10 – Office of Economic Development budget to provide for the grant from the Upper Shore Regional Council  
11 awarded to Cecil County; and

12           **WHEREAS**, such appropriation is necessary to provide \$27,000 in program funding to allow for an  
13 Agriculture Microgrant Program, specifically designed to help between ten and thirty Cecil County  
14 agricultural enterprises with projects to start, expand, diversify or market their business or projects, which  
15 enhance educational and research initiatives on the farm.

16           **NOW THEREFORE, BE IT HEREBY RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY,**  
17 **MARYLAND**, that the Annual Budget and Appropriation Ordinance for Cecil County, Maryland, for Fiscal  
18 Year 2022, is hereby amended for the supplemental appropriation; and by amending the Current Budget  
19 to appropriate \$27,000 in additional expenditures, in the Special Revenue Other Grants Fund – Office of  
20 Economic Development, in order to record the grant awarded from the Upper Shore Regional Council, for  
21 the purpose of an Agriculture Microgrant Program in Cecil County.

22           **AND, BE IT FURTHER RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND**, that  
23 this Resolution shall take effect on the date of its passage.
