1 **WHEREAS**, Pursuant to Article II, Section 191-6A of the Code of Cecil County, the County Executive
2 shall appoint a board which shall be known as the "Board of Electrical Examiners," consisting of seven
3 persons for the purpose of examining the qualifications and capabilities of all persons who are engaged in,
4 or desire to engage in the business of master electrician or limited electrician as defined in this chapter;
5 and

6 **WHEREAS**, Pursuant to Chapter 191, Article II, Section 191-10 of the Code of Cecil County, the
7 Board of Electrical Examiners shall advise the County, and aid in the supervision and enforcement of any
8 rule or regulation adopted, pursuant to the authority of the Code and Maryland law; and the Board shall
9 act as an appeals board concerning matters arising under the adopted code and any licensing provisions;
10 and

11 **WHEREAS**, Pursuant to Article II, Section 191-6B of the Code of Cecil County, the County Executive
12 shall appoint seven members, all being residents of Cecil County, and so appointed shall consist of at least
13 four persons who are master electricians, and one member shall be a person whose name appears on a
14 list of candidates recommended by the Cecil County Fireman's Association, if submitted; and

15 **WHEREAS**, Article 4, Section 412 (b) of the Charter of Cecil County provides that the County
16 Executive shall appoint all members of boards and commissions, subject to confirmation by the Council;
17 and

18 **WHEREAS**, the County Executive has appointed Richard LeBrun and Donald Hicks to serve a 3 year
19 term to expire January 4, 2025.

20 **NOW, THEREFORE, BE IT HEREBY RESOLVED THAT THE COUNTY COUNCIL OF CECIL COUNTY,**
21 **MARYLAND**, that the appointment of Richard LeBrun and Donald Hicks to the Electrical Examiners Board
22 for a three year term to expire on January 4, 2025 is confirmed.

23 **AND, BE IT FURTHER RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND,** that
24 this Resolution shall take effect on the date of its passage.
