- Lawrence Scott, County Attorney, provided an overview of the meeting with the State Ethics Commission.
- Will Colquhoun provided counsel that no Ethics Commission member may exempt themselves from filing a financial disclosure.
- Motion made by Charles Kelso, to task Lawrence Scott, County Attorney to draft a letter to previous Ethics Commission members to submit a 2019 and 2020 financial disclosure before October 29, 2021 with statement that failure to submit may lead to a fine. Motion seconded by Heather O'Rourke, approved by all.
- Motion made by Charles Kelso to task Lawrence Scott, County Attorney, to continue collaboration with the State Ethics Commission to incorporate newly passed state legislation into the County's Public Ethics Law. Motion seconded by Heather O'Rourke, approved by all.
- Ashton Ross provided an update of 2020 financial disclosure forms for County employees and board members. Approximately 75% of the employees and board members have complied.
- Motion made by Charles Kelso to task DHR and Ashton Ross to follow up on those County employees and board members who are non-compliant for 2020. Motion seconded by Heather O'Rourke, approved by all.
- o Andrew Goins, Chair, requested update from Lawrence Scott regarding revising the financial disclosure forms.
- o Lawrence Scott indicated the requirements on forms must meet the minimum requirements of State Ethic's Law.
- Andrew Goins asked for clarification on those required to file State Ethics forms, can Cecil County require a confirmation. Ashton Ross will investigate and provide update at the next meeting.
