COUNTY COUNCIL OF CECIL COUNTY LEGISLATIVE SESSION MINUTES LSD 2021-24 December 21, 2021

The County Council of Cecil County met in legislative session at the County Administration Building, 200 Chesapeake Blvd., Elk Room, Elkton, MD. The following members of the Council were present:

CALL TO ORDER

The meeting of the County Council of Cecil County of December 21, 2021 was called to order by Council President Meffley at 7:00 p.m. Council President Meffley led the audience in the Pledge of Allegiance.

OPENING PRAYER

Council Member Miller introduced Pastor Steve Basht from Janes United Methodist Church in Rising Sun, who led the opening prayer.

APPROVAL OF AGENDA

On motion made by Vice President Gregory, seconded by Councilman Coutz, the Council moved to approve the legislative agenda of December 21, 2021. Motion was approved unanimously.

APPROVAL OF MINUTES

On motion made by Councilman Coutz, seconded by Vice President Gregory, the Council moved to approve the minutes of the legislative session of December 7, 2021. Motion was approved unanimously.

PUBLIC COMMENTS

Marcus Webster, Voices of Hope, commended the Council for their commitment to addressing drug addiction.

Heather Lyons, North East, commented in support of backyard chicken legislation. Bob Gatchell, Port Deposit, commented in support of backyard chicken legislation. Linda Meffley, Chesapeake City, commented in support of COVID vaccinations.

PRESIDENT AND COUNCIL COMMENTS

Councilman Coutz thanked the audience for attending and wished them Merry Christmas and Happy New Year. He attended the Cecil County Watershed Stewards Academy graduation and commended their North East rain garden capstone project. He participated in the Rockin' Reader program at

Cecil Manor Elementary School. He reported on statistics from the Sheriff's Office Intel meeting that showed most calls for service has increased. He also stated that 2021 has shown a significant increase in overdose fatalities. He congratulated Caleb and Alice Crothers, and Amanda and Westley Miller, who received the Farmers on the Rise awards from the Mid Atlantic Farm Credit. He voiced his concern about the number of COVID patients in Christiana Care Union Hospital.

Councilman Miller attended the Firemen's Association meeting and asked everyone to pray for our firefighters who have been very busy. He wished everyone a Merry Christmas.

Councilwoman Culberson expressed her concern over the impact of Chester County hospitals closing in Jennersville and Bryn Mawr. She wished everyone Happy Holidays.

Vice President Gregory wished everyone Merry Christmas and Happy New Year. She requested that public comments regarding the backyard chicken legislation be read into the record. Council Manager Massey read comments from Donna Caudill and John Stricklett in support of this legislation.

Council President Meffley commented on the Residential Noise Committee members being a balance of homeowners, business, and law enforcement. He attended the Firemen's Association meeting and commented on the county's purchase of ambulances for Cecilton and Hacks Point. He commended volunteer fire companies for their great public service to the county.

Bill No. 2021-16 Amendment – Zoning Ordinance – Animal Husbandry – Backyard Chickens An Act to amend the Cecil County Zoning Ordinance, Article V, Part I, Section 58, Animal Husbandry in order to add and define backyard chickens raised in specific residential zones.

Vice President Gregory, Bill sponsor, provided comments. Vice President Gregory read an additional comment from Austin Nester in support of the legislation. There were no Council questions or comments.

Introduced, read first time, and order posted on December 21, 2021. The Bill will be scheduled and advertised for public hearing on January 18, 2022.

A Bill to amend the Annual Budget and Appropriation Ordinance for Cecil County, Maryland, for the fiscal year ending June 30, 2022, in order to appropriate expenditure authority within the Roads and Bridges Capital Projects Budget in the amount of \$750,000 from the General Fund – Assignment of Fund Balance.

The Bill was introduced and posted on November 2, 2021; the public hearing was held and concluded on December 7, 2021; and scheduled for final consideration on December 21, 2021.

Cecil County Public Schools – Budget Amendment # 93

Councilman Coutz made a motion to approve Budget Amendment #93, in the amount of \$496,531 for November 2021 expenses. The motion was seconded by Vice President Gregory. The Council approved the motion unanimously by a voice vote of 5 to 0.
