1	WHEREAS, pursuant to Section 23-401 of the Education Article of the Annotated Code of
2	Maryland, the county governing body may establish a county public library system free from political
3	influence; and
4	WHEREAS, each county public library system shall be governed by a board of trustees; and
5	WHEREAS, pursuant to Section 23-403 of the Education Article of the Annotated Code of
6	Maryland, each board of library trustees consists of seven members appointed by the county governing
7	body from nominees submitted by the board of library trustees; and
8	WHEREAS, pursuant to Section 23-405 of the Education Article of the Annotated Code of
9	Maryland, each board of library trustees has the powers and duties to establish and operate the library,
10	determine library policies, adopt rules, regulations and bylaws for the use of the library, approve the
11	library budget and spending of public funds, and approve the annual audit and annual report; and
12	WHEREAS, Section 412 (b) of Article 4 of the Charter of Cecil County provides that the County
13	Executive shall appoint all members of boards and commissions, subject to confirmation by the Council;
14	and
15	WHEREAS, the County Executive has recommended Tanya Area for reappointment to the Cecil
16	County Board of Library Trustees, to a five year term which is to expire on February 14, 2027.
17	NOW, THEREFORE, BE IT HEREBY RESOLVED THAT THE COUNTY COUNCIL OF CECIL COUNTY,
18	MARYLAND, confirms the recommendation by the County Executive of Tanya Area for reappointment to
19	the Cecil County Board of Library Trustees, to a five year term which is to expire on February 14, 2027.
20	AND, BE IT FURTHER RESOLVED that this Resolution shall take effect on the date of its passage by
21	the County Council of Cecil County, Maryland.
