WHEREAS, it is the policy of the State that adults who lack the physical or mental capacity to care
for their basic daily living needs shall have access to and be provided with needed professional services to
protect their health, safety and welfare; pursuant to Section 14-102 (Legislative policy and intent) of the
Maryland Annotated Code, Family Law Article, Title 14 (Adult Protective Services); and
WHEREAS, the Maryland Secretary of Human Resources shall develop, supervise, and cause each
local department to implement a program of protective services for vulnerable adults, pursuant to Section
14-201 of the Family Law Article of the Maryland Annotated Code; and
WHEREAS, there shall be at least one review board established in each county; pursuant to
Section 14-401(a) of the Family Law Article of the Maryland Annotated Code; and
WHEREAS, the review board shall review each guardianship that a public agency holds at least
once a year and shall conduct a file review at least every six months, pursuant to Section 14-404 of the
Family Law Article of the Maryland Annotated Code; and
WHEREAS, the Cecil County Adult Public Guardianship Review Board is an interdisciplinary team
that acts as a consultant to the public guardians, reviewing public guardianship cases every six months
and making recommendations to the court to continue, modify, or terminate guardianship of the person;
and
WHEREAS, Article 4, Section 412 (b) of the Charter of Cecil County provides that the County
Executive shall appoint all members of boards and commissions, subject to confirmation by the Council;
and
WHEREAS, the County Executive has recommended Erin Bird and E. Sean Poltrack for appointment
to the Adult Public Guardianship Review Board to a three year term, which is to expire on March 15, 2025.
NOW, THEREFORE, BE IT HEREBY RESOLVED THAT THE COUNTY COUNCIL OF CECIL COUNTY,
MARYLAND, confirms the recommendation by the County Executive of Erin Bird and E. Sean Poltrack for
appointment to the Adult Public Guardianship Review Board to a three year term, which is to expire on
March 15, 2025.
AND BE IT FURTHER RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND, that
