Supplemental Appropriation – Grant Funds – Community Services –
The Bridge and Domestic Violence and Rape Crisis Center

1 **WHEREAS**, in accordance with Section 505 of the Cecil County Charter, on April 1, 2021, the
2 County Executive submitted a proposed budget to the County Council for Fiscal Year 2022; and

3 **WHEREAS**, in accordance with Section 506 of the Cecil County Charter, the Cecil County Council
4 held public hearings on the proposed budget submitted by the County Executive for Fiscal Year 2022; and

5 **WHEREAS**, in accordance with Section 507(b) of the Cecil County Charter, on June 1, 2021, the
6 Budget for Cecil County was adopted for Fiscal Year 2022; and

7 **WHEREAS**, the County Executive is revising the Fiscal Year 2022 Special Revenue Other Grants
8 Fund – Department of Community Services revenue estimate to establish the following amount: the
9 addition of \$55,000 in grant revenue and expense to the Community Services Grants Fund – Department
10 of Community Services budget, in order to provide for the grant from the United States Department of
11 Justice, Office of Justice Programs, Office of Juvenile Justice and Delinquency Prevention (OJJDP); and

12 **WHEREAS**, such appropriation is necessary to provide \$55,000 in program funding to allow for a
13 grant program specifically designed to address trauma and substance use.

14 **NOW THEREFORE, BE IT HEREBY RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY,**
15 **MARYLAND**, that the Annual Budget and Appropriation Ordinance for Cecil County, Maryland, for Fiscal
16 Year 2022 is hereby amended for the supplemental appropriation; and by amending the Current Budget
17 to appropriate \$55,000 in additional expenditures in the Community Services Grants Fund – Department
18 of Community Services to record the grant awarded through the Maryland Network Against Domestic
19 Violence to The Bridge/Cecil County Domestic Violence and Rape Crisis Center.

20 **AND, BE IT FURTHER RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND**, that
21 this Resolution shall take effect on the date of its passage by the County Council of Cecil County,
22 Maryland.

SUMMARY OF LEGISLATION

SPONSOR: Council President at the request of the County Executive

RESOLUTION NO. 05-2022 – SUPPLEMENTAL APPROPRIATION – GRANT FUNDS – COMMUNITY SERVICES – THE BRIDGE AND DOMESTIC VIOLENCE AND RAPE CRISIS CENTER.

SYNOPSIS: A Resolution to amend the Annual Budget and Appropriation Ordinance for Cecil County, Maryland, for the fiscal year ending June 30, 2022, in order to provide a total of \$55,000 to the Community Services Grants Fund – Department of Community Services, to record a grant awarded through the Maryland Network Against Domestic Violence to The Bridge/Cecil County Domestic Violence and Rape Crisis Center to cover costs associated with personnel and staffing.

FISCAL IMPACT SUMMARY: Net fiscal impact to the County will be zero for Fiscal 2022. The grant funding will have offsetting expenses.

FISCAL ANALYSIS:

The addition of \$55,000 in grant revenue and expense within the Community Services Grants Fund – Department of Community Services from the Domestic Violence Grant will fund a program to cover costs associated with personnel and staffing. The grant award originated from the American Rescue Plan Act, designated for response to domestic violence; Maryland's total award was allocated to the Maryland Network Against Domestic Violence to disseminate to the State's Domestic Violence Programs.
