5	WHEREAS, in accordance with Section 507(b) of the Cecil County Charter, on June 01, 2021, the
6	Budget for Cecil County was adopted for Fiscal Year 2022; and
7	WHEREAS, the County Executive is revising the Fiscal Year 2022 Special Revenue Other Grants
8	Fund – Office of Economic Development revenue estimate for Cecil County in order to establish the
9	following amount: the addition of 323,991 in grant revenue and expense to the Community Services
10	Grants Fund – Department of Community Services budget, to provide for the grant from the American
11	Rescue Plan Act of 2021; and
12	WHEREAS, such appropriation is necessary to provide \$323,991 in program funding to carry out
13	activities and services related to the Older Americans Act of 1965.
14	NOW THEREFORE, BE IT HEREBY RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY,
15	MARYLAND, that the Annual Budget and Appropriation Ordinance for Cecil County, Maryland, for Fiscal
16	Year ending June 30,2022 is amended for the supplemental appropriation; and by amending the Current
17	Budget, to appropriate \$323,991 in additional expenditures in the Community Services Grants Fund –
18	Department of Community Services, to record the grant awarded through the American Rescue Plan Act
19	of 2021.

21	this Resolution shall take effect on the date of its passage by the County Council of Cecil County,
