Mr. Lawrence asked if the information in the application as submitted had changed since submitting; the applicants stated no. Chairman Miller stated the food is wonderful. Mr. Riddle stated the Old Smokehouse was located three doors down with limited parking: Prost German Restaurant moved to Harford County which allowed Mr. Kelso to pursue the location. Mr. Riddle continued same restaurant, more employees, more parking, same menu, same drink selection, new location. Mr. Scott asked Mr. Kelso about the license at the previous location; Mr. Kelso stated he may have someone to lease that property; Mr. Scott had Chief Inspector Bradford remind Mr. Kelso that the business needs to be open 30 continuous days in a 12-month period to keep the license active; Mr. Kelso stated that won't be an issue. Chairman Miller asked if anyone was present for or against this transfer, there was no one. Chairman Miller asked if there were any questions, there were none. Eriksson Hill appeared before the Board with attorney, John Downes. Chief Bradford read his report into the record. He also read Local Rules & Regulation #13 - Alteration or Change to Mode of Operation. Chief Bradford stated there were two events, one at Chesapeake Overlook and the other at Chateau Bu-De, where alcohol was sold; he stated he can't be sure who provided the alcohol; Mr. Hill interjected and said it was not him; Chief Bradford continued, but we do not have a special for either event or a catered events form, so someone was in violation at those events. Chief Bradford presented a photo showing alcohol on the table, a price menu, and Hill Culinary cards in the middle. Mr. Downes stated the context was not being disputed, the Facebook post was a business man's spin on an unsuccessful business. Mr. Downes explained that Mr. Hill is having trouble getting employees who want to work, running the restaurant, as well as the catering business. Mr. Hill stated of the events he caters he probably uses his license at 1% of those events; Mr. Hill stated he was in no way trying to deceive the Board or do anything illegal, it was such an oversight, and it wasn't until he received the letter that he realized he hadn't advised the Board that this was happening. Mr. Hill continued that ideally, he would like until January or February, hoping the employment issue is better and he can take the time to reorganize his business plan. This led to a discussion as to why he needed a license. Chairman Miller stated there is not a license just for catering: to be able to cater events you must hold a regular liquor license. Chairman Miller called for a motion; Commissioner Ortt made a motion to grant three months to Mr. Hill to reorganize his business plan and regarding the violation, recommends a \$250 fine; Chairman Miller seconded that motion and the Board unanimously approved to grant three months to Mr. Hill to reorganize his business plan and \$250 fine.
