1 **WHEREAS**, Maryland’s Enterprise Tax Credit Program is a joint effort between the State
2 and local governments to provide tax incentives to businesses and property-owners located in
3 economically distressed communities; and

4 **WHEREAS**, the Cecil County Enterprise Zone was approved by the State of Maryland on
5 June 15, 2013, thus providing an important economic development tool for the County and the
6 towns of Perryville, North East and Elkton; and

7 **WHEREAS**, the Cecil County Office of Economic Development desires to have the
8 current Enterprise Zone expanded to allow existing businesses in Cecil County and prospective
9 new businesses to utilize these incentives; and

10 **WHEREAS**, the application will include all those seven (7) properties shown on the
11 attached map and associated parcel listing in Exhibit A, in all totaling 391.86 acres, more or less;
12 and

13 **WHEREAS**, the primary benefits to businesses that are located within an enterprise zone
14 are eligibility for local property tax credits and State income tax credits; and

15 **WHEREAS**, eligible businesses in an enterprise zone may claim a ten-year credit against
16 local real property taxes on a portion of real property improvements. The credit is 80 percent
17 of the assessment increase during the first five years. The credit then decreases 10 percent
18 annually thereafter to 30 percent in the tenth year; and

19 **WHEREAS**, eligible businesses in an enterprise zone may claim a one-time \$1,000
20 income tax credit for wages paid to each new employee in a new position. For new
21 economically disadvantaged employees, the credit increases to a total of \$6,000 per worker
22 distributed over three years. Businesses claim the enterprise zone income tax credits on
23 Maryland 500CR form when they submit their business or individual income tax returns to the
24 Comptroller; and

25 **WHEREAS**, the Enterprise Zone is an important incentive for the County to encourage
26 existing businesses to expand and in attracting new businesses to locate within Cecil County;
27 and

28 **WHEREAS**, the application for the subject Enterprise Zone must be filed with the State
29 of Maryland Department of Commerce on or before April 15, 2022.

30 **NOW, THEREFORE, BE IT HEREBY RESOLVED BY THE COUNTY COUNCIL OF CECIL**
31 **COUNTY, MARYLAND**, that this application to expand the Cecil County Enterprise Zone to
32 include seven (7) parcels totaling 391.86 acres, more or less, as reflected in Exhibit A, as
33 attached, is approved.

34 **AND BE IT HEREBY FURTHER RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY,**
35 **MARYLAND**, that this Resolution shall take effect on the date of its passage.
