Supplemental Appropriation – Grant Funds – Community Services – Older Americans Act Activities

1 **WHEREAS**, in accordance with Section 505 of the Cecil County Charter, on April 1, 2021, the
2 County Executive submitted a proposed budget to the County Council for Fiscal Year 2022; and

3 **WHEREAS**, in accordance with Section 506 of the Cecil County Charter, the County Council held
4 public hearings on the proposed budget submitted by the County Executive for Fiscal Year 2022; and

5 **WHEREAS**, in accordance with Section 507(b) of the Cecil County Charter, on June 01, 2021, the
6 Budget for Cecil County was adopted for Fiscal Year 2022; and

7 **WHEREAS**, the County Executive is revising the Fiscal Year 2022 Special Revenue Other Grants
8 Fund – Department of Community Services revenue estimate for Cecil County in order to establish the
9 following amount: the addition of 323,991 in grant revenue and expense to the Community Services
10 Grants Fund – Department of Community Services budget, to provide for the grant from the American
11 Rescue Plan Act of 2021; and

12 **WHEREAS**, such appropriation is necessary to provide \$323,991 in program funding to carry out
13 activities and services related to the Older Americans Act of 1965.

14 **NOW THEREFORE, BE IT HEREBY RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY,**
15 **MARYLAND**, that the Annual Budget and Appropriation Ordinance for Cecil County, Maryland, for Fiscal
16 Year ending June 30,2022 is amended for the supplemental appropriation; and by amending the Current
17 Budget, to appropriate \$323,991 in additional expenditures in the Community Services Grants Fund –
18 Department of Community Services, to record the grant awarded through the American Rescue Plan Act
19 of 2021.

20 **AND, BE IT FURTHER RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND**, that
21 this Resolution shall take effect on the date of its passage by the County Council of Cecil County,
22 Maryland.

SUMMARY OF LEGISLATION

SPONSOR: Council President at the request of the County Executive

Resolution No. 14-2022 Supplemental Appropriation – Grant Funds – Community Services – Older American Act Activities

SYNOPSIS: A Resolution to amend the Annual Budget and Appropriation Ordinance for Cecil County, Maryland, for the fiscal year ending June 30, 2022, in order to provide a total of \$323,991 to the Community Services Grants Fund – Department of Community Services, to record a 3-year grant awarded through the Maryland Department of Aging, to carry out activities under the Older Americans Act of 1965.

FISCAL IMPACT SUMMARY: Net fiscal impact to the County will be zero for Fiscal 2022. The grant funding will have offsetting expenses.

FISCAL ANALYSIS:

The addition of \$323,991 in grant revenue and expense within the Community Services Grants Fund – Department of Community Services from the American Rescue Plan Act of 2021 will fund a program to carry out activities and services related to the Older Americans Act of 1965. The total allocation will be disseminated through the Maryland Department of Aging and will cover costs associated with Nutrition, Supportive and Preventative Health Services and Programming and Personnel.
