WHEREAS, the Board of Parks and Recreation with powers and duties was created, pursuant to 1 2 Chapter 16, Article II, Section 16-7; and 3 WHEREAS, the Board of Parks and Recreation is authorized to determine all questions of general 4 policy relating to parks and public recreation in Cecil County, to supervise the expenditure of funds 5 appropriated to these purposes, and to keep the County informed as the availability of federal and state funds for these purposes according to Chapter 16, Article II, Section 16-9 of the Code of Cecil County; and 6 7 WHEREAS, the Board of Parks and Recreation shall consist of eight members, one member being 8 appointed by the Board of Education; and WHEREAS, Article 4, Section 412 (b) of the Charter of Cecil County provides that the County 9 10 Executive shall appoint all members of boards and commissions, subject to confirmation by the Council; 11 and WHEREAS, the County Executive has recommended Matthew Morris and Bernard Brown, III, for 12 reappointment to the Board of Parks and Recreation for a three (3) year-term which is to expire on 13 14 April 1, 2025. 15 NOW, THEREFORE, BE IT HEREBY RESOLVED THAT THE COUNTY COUNCIL OF CECIL COUNTY, 16

MARYLAND, confirms the recommendation by the County Executive of Matthew Morris and Bernard Brown, III for reappointment to the Board of Parks and Recreation for a three (3) year term, which is to expire on April 1, 2025.
