| WHEREAS, the Commission for Women was created to raise awareness of issues affecting women |

| and families; and to advocate for women and families in order to assist them in attaining the best quality |
| of life for themselves and their families, pursuant to Chapter 16, Article II, Section 16-19 of the Code of |
| Cecil County; and |

WHEREAS, the Commission for Women shall consist of twelve (12) members who represent a cross section of the County and shall be selected because of their known experience and active interest in women's and family issues and the purposes of the Commission, pursuant to Section 16-20 of the Code; and

WHEREAS, the Commission shall select from its own membership a Chairperson, Vice-Chairperson, and Secretary-Treasurer, each to serve at the pleasure of the Commission, pursuant to Section 16-21(C) of the Code; and

WHEREAS, a Commission member may not receive compensation but is entitled to reimbursement for expenses, as provided in the Commission's budget, pursuant to Section 16-21(B); and

WHEREAS, the Commission shall adopt rules and regulations necessary to govern its procedure and business; and shall meet as frequently as required to perform its duties, but no less than two times each year; pursuant to Section 16-22 of the Code; and

WHEREAS, the County Executive shall appoint members from recommendations made by organizations and agencies in the County dedicated to improving the quality of life for the citizens of Cecil County, pursuant to Section 16-20(B) of the Code; and

WHEREAS, for the initial establishment of the first Commission, one-third of the members shall serve for one year, one-third for two years, and one-third for three years; and thereafter, the terms of all members shall be three years, pursuant to Section 16-21(A)(1) of the Code; and

WHEREAS, at the end of a term, a Commission member continues to serve until a successor is appointed and qualifies, pursuant to Section 16-21(A)(2) of the Code; and

WHEREAS, a Commission member who is appointed after a term has begun serves only for the rest of the term and until a successor is appointed and qualifies, pursuant to Section 16-21(A)(3); and

WHEREAS, the Commission shall submit an annual report to the County summarizing its activities during the preceding year, pursuant to Section 16-23 of the Code; and

WHEREAS, Article 4, Section 412 (b) of the Charter of Cecil County provides that the County Executive shall appoint all members of boards and commissions, subject to confirmation by the Council; and

WHEREAS, the County Executive has recommended Sheila Murphy, Kathleen Kennedy, Casie Goins, and Annette Brown for a three (3) year term, to the Commission for Women which is to expire on April 5, 2025; and Tammy Perkins for a two (2) year term, for appointment to the Commission for Women which is to expire on April 5, 2024.

NOW, THEREFORE, BE IT HEREBY RESOLVED THAT THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND, confirms the recommendation by the County Executive of Sheila Murphy, Kathleen Kennedy, Casie Goins, and Annette Brown for a three (3) year term, to the Commission for Women which is to expire on April 5, 2025; and Tammy Perkins for a two (2) year term, for appointment to the Commission for Women which is to expire on April 5, 2024.

AND, BE IT FURTHER RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND, that this Resolution shall take effect on the date of its passage by the County Council of Cecil County, Maryland.
