1 **WHEREAS**, Pursuant to Maryland Annotated Code, Agriculture Article, Section 9-2402(4), the
2 Secretary of Agriculture may enter into agreements with any county or subdivision of the State to effect a
3 program of control and eradication of noxious weeds; and

4 **WHEREAS**, Pursuant to a Memorandum of Understanding between the Maryland Department of
5 Agriculture and Cecil County, which was approved by the Cecil County Board of Commissioners on March
6 16, 2010, the Cecil County Board of County Commissioners agreed to appoint a Weed Advisory
7 Committee to assist the Department of Agriculture in developing and implementing a Noxious Weed
8 Control Program; and

9 **WHEREAS**, the Weed Advisory Committee of Cecil County works with the Roads Division of the
10 Department of Public Works in providing oversight for the weed control program; and

11 **WHEREAS**, Article 4, Section 412 (b) of the Charter of Cecil County provides that the County
12 Executive shall appoint all members of boards and commissions, subject to confirmation by the Council;
13 and

14 **WHEREAS**, the County Executive has recommended the reappointment of Michael Scheeler and
15 William Ewing; and the appointment of Scott Heaps and Jessica Lynn Edge to the Cecil County Weed
16 Control Advisory Board for a one (1) year term, to expire April 19, 2023.

17 **NOW, THEREFORE, BE IT HEREBY RESOLVED THAT THE COUNTY COUNCIL OF CECIL COUNTY,**
18 **MARYLAND**, confirms the recommendation by the County Executive of the reappointment of
19 Michael Scheeler and William Ewing; and the appointment of Scott Heaps and Jessica Lynn Edge to the
20 Cecil County Weed Control Advisory Board for a one (1) year term, to expire April 19, 2023.

21 **AND, BE IT FURTHER RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND**, that
22 this Resolution shall take effect on the date of its passage.
