1           **WHEREAS**, pursuant to the provisions of the Human Services Article of the Annotated Code  
2 of Maryland, Section 3-501, each local Department of Social Services shall have a local board  
3 consisting of at least nine (9), but no more than thirteen (13) members who have a high degree of  
4 interest, capacity, and objectivity; and in the aggregate, give a countywide representative character  
5 to the local board, and

6           **WHEREAS**, Title 3, Subtitle 5, Section 3-503 of the Annotated Code of Maryland defines the  
7 duties and functions of a local Social Services Board as an advisory board to the local director for the  
8 local application and implementation of State policies or procedures, which includes evaluating and  
9 making recommendations to improve current services and develop new services as needed in the  
10 county; and serving as the liaison with the local government authority and residents to  
11 communicate the objectives, policies and programs of local social services and public assistance  
12 administration; and

13           **WHEREAS**, Article 4, Section 412 (b) of the Charter of Cecil County provides that the County  
14 Executive shall appoint all members of boards and commissions, subject to confirmation by the  
15 Council; and

16           **WHEREAS**, the County Executive has recommended the appointment of Berkeley Orr, Glenn  
17 Jensen, and Abigail Hooper to the Department of Social Services Board, for a three (3) year term, to  
18 expire April 19, 2025.

19           **NOW, THEREFORE, BE IT HEREBY RESOLVED THAT THE COUNTY COUNCIL OF CECIL**  
20 **COUNTY, MARYLAND**, confirms the recommendation by the County Executive for the appointment  
21 of Berkeley Orr, Glenn Jensen, and Abigail Hooper to the Department of Social Services Board, for a  
22 three (3) year term, to expire April 19, 2025.

23           **AND BE IT FURTHER RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND,**  
24 that this Resolution shall take effect on the date of its passage.
